ARRA Project Description:

Crystal City Heights Road is a north-south connector that runs from Missouri Avenue to Commercial Boulevard (Hwy 61). The City recently applied for American Recovery and Reinvestment Act (ARRA) federal stimulus funds earlier this year to construct the project this summer. The project will include professional construction engineering services that must be provided in accordance with MoDOT Public Agency STP Guidelines and the new rules which have been recently instituted in association with the ARRA guidelines.

Should you believe that your firm is qualified within the disciplines of construction engineering and inspection services and would like to be considered, we would appreciate your submission of qualifications based on the following criteria:

1. The specialized experience and technical competence of the firm with respect to the type of services required.
2. Experience meeting requirements of the Federal Highway Administration, the Missouri Department of Transportation and Local Public Agency Process for STP funded projects. In addition, experience performing construction engineering services on STP projects in accordance with the MoDOT LPA Manual regarding Construction Testing and Inspection.
3. The capacity and capability of the firm to perform the work in question, including specialized services, within the time limitations fixed for the completion of the project.
4. The past record of performance of the firm with respect to such factors as control of costs, quality of work, and ability to meet schedules.
5. The firm's proximity to and familiarity with the area in which the project is located.

The selected Consultant will be required to apply and receive a DUNS number.
