

REQUEST FOR BIDS

Sealed Bids for the Chesterfield Compressed Natural Gas (CNG) Vehicles and Fueling Station, CMAQ-5410(627), Bid Packages #1, #2A, #2B, #2C, #2D will be received by the City of Chesterfield Department of Public Services, 690 Chesterfield Pkwy W, Chesterfield, Missouri, 63017-0760 until **10:00 AM (prevailing central time) on Wednesday, February 22, 2017** and will thereafter be publicly opened and read aloud. All bids shall be submitted in paper form.

This request for bids is separated into five (5) bid packages. Bidders may submit bids on any one or all bid packages. All bid packages must be submitted in separate sealed envelopes. Bid package #1 is for the construction of a fast-fill CNG fueling facility, including site work, equipment for drying, compressing, dispensing, and managing fuel and other necessary components for the proper function of the facility as detailed in Bid Package #1 specifications and drawings. Bid Packages #2A to #2D include the procurement of twelve (12) new CNG trucks outfitted for plowing snow and spreading salt and one (1) CNG Cargo Van as detailed in the following:

- Bid Package #2A – CNG Light Duty Class 3 (1 Ton) Trucks - Quantity: 2
- Bid Package #2B – CNG Medium Duty Class 5 (1.5 Ton) Trucks – Quantity: 3
- Bid Package #2C – CNG Medium Duty Class 7 (2.5 Ton) Trucks – Quantity: 7
- Bid Package #2D – CNG Light Duty Class 2b (1 Ton) Cargo Van – Quantity: 1

All Bid packages will be available in form of “.pdf” electronic files which may be downloaded from the City’s website at <http://chesterfield.mo.us/request-for-proposals.html> or may be picked up on a compact disk (CD) from Chesterfield City Hall beginning **Tuesday, February 7, 2017**. When downloading or picking up a bid packet, you will be required to provide your name and company information on a bidder’s list record and furnish an email address for receiving official bidding communications and addenda. Communications between the bidders and the City shall be conducted and documented in writing through the use of email communication to ckrueger@chesterfield.mo.us. No oral interpretation will be recognized.

An optional pre-bid conference will be held at **9:00 AM on Tuesday, February 14, 2017** for the vehicle bid packages #2A to #2D and **10:00 AM** for Fueling Station Bid Package #1 at Chesterfield Public Works Facility at 165 Public Works Drive, Chesterfield, MO 63005. All bidders are encouraged to attend the pre-bid meeting.

The City of Chesterfield hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, business owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

Required for Bid Package #1 – Fueling Station

1. All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.
2. Contractors and sub-contractors who sign a contract to work on public works projects shall provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.
3. A certified or cashier’s check or a bid bond in the amount of 5% shall be submitted with each proposal.
4. The DBE Goal for Bid Package #1 is 4%.
5. No 2nd Tier Subcontracting will be allowed on this project.

The City reserves the right to reject any and all Bids. No Bid may be withdrawn for a period of sixty (60) days subsequent to the specified time for receipt of Bids. The project will be awarded to the lowest, responsive, and responsible bidder for each bid package.
