

**INVITATION FOR BIDS**

Sealed bids for the City of Versailles, MO 65084. Versailles Sidewalk Improvement, Federal Project Number TAP-9901(508) Cochran Project Number LOR16-110 (hereinafter "Project") will be received by Versailles City Hall, 104 N. Fisher Street Versailles, Missouri 65084, until 2:00 p.m. local time, on Friday July 20, 2018, at which time the bids will be publicly opened and read aloud.

The Scope of Work includes the removal of existing sidewalk curb ramps, building new concrete ADA curb ramps, pavement striping, traffic control, new concrete block building wall, backfill and other incidental items and work described in the Project Manual, or reasonably inferable therefrom. The City of Versailles, MO anticipates issuing notice to proceed in August of 2018. A pre bid meeting will be held on July 12, 2018 at 2:00 p.m. at Versailles City Hall 104 N. Fisher Street Versailles, MO.

Bid packages will be available after 10:00 a.m. on June 22, 2018 and may be obtained from Cochran 905 Executive Drive, Osage Beach, Missouri 65065, between the hours of 8:00 a.m. and 4:00 p.m., Monday through Friday, upon payment of a non-refundable fee of \$100.00 per set. Make checks payable to Cochran. For directions, please call 573-525-0299. To obtain a bid package, the bidder must provide all contact information requested on the Plan Holders List.

A bid security in the amount of five percent (5%) of the bid amount must accompany each bid, in accordance with the Instructions to Bidders.

For a contractor to be awarded this project the contractor must have a fully responsive contractor questionnaire on file with the Missouri Highway and Transportation Commission at least 7 days prior to the bid opening date. No Second Tier Subcontracting will be allowed.

The wage rates applicable to this project have been predetermined as required by law and are set forth in this specification. When Federal wage rates are applicable and included, this contract is subject to the "Work Hours Act of 1962", (P.L. 87-581: 76 Stat. 357) and implementing regulations. When state and federal wage rates are both required the higher of the two for each job classification shall be used.

Effective January 1, 2009 and pursuant to RSMo 285.530 (1), No business entity or employer shall knowingly employ, hire for employment, or continue to employ an unauthorized alien to perform work within the state of Missouri. The successful bidder must submit a sworn affidavit and documentation affirming the business entity's enrollment and participation in the federal work authorization program and that all of its employees working for the contracted services are not illegal immigrants.

Upon signing the contract, the successful contractor and any subcontractor performing the work shall provide a ten-hour Occupational Safety and Health Administration (OSHA) construction safety program for their on-site employees.

The City of Versailles, Missouri hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

The DBE Contract Goal for this project is 4%, and DBE firms must be certified by MoDOT to attain credit towards this contract goal. There is no on the job trainee goal.
