

# CONSTRUCTION OF CLEVER, MISSOURI SIDEWALK IMPROVEMENTS – PHASE IV

## ADVERTISEMENT FOR BIDS

Sealed bids TAP-3321(417) Construction of Sidewalk Improvements – Phase IV, will be received at Clever City Hall, 304 S. Clarke, in Clever, Missouri until 11:00 o'clock A.M. (Prevailing Local Time) on the 24th day of April, at Clever City Hall, 304 S. Clarke, in Clever, Missouri, and at that time will be publicly opened and read. All bids shall be submitted in the form of sealed envelopes endorsed "Proposal For Construction of Sidewalk Improvements – Phase IV". Proposals must be on forms provided and all unit price bids, extensions and total provided thereon shall be completed fully.

The proposed work generally includes construction of 5' wide sidewalk, access ramps, culverts, and any incidental work related thereto in accordance with the plans and specifications. The project is generally located in various locations in the City of Clever, Christian County, Missouri. The total length of the improvements is approximately 3,512 feet.

Plans and specifications may be purchased from the office of Anderson Engineering, 2045 West Woodland, Springfield, Missouri, for a fee of \$65.00. All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The City of Clever and the Clever R-V School District hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2017 Edition including all revisions.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

The Clever R-V School District and the City of Clever reserves the right to reject any or all bids.

The DBE Goal for this project is 8%.

No 2<sup>nd</sup> tier subcontracting will be allowed on this project.
