NOTICE TO BIDDERS

Sealed bids for the Proposal for the Construction of Greene County Bridge #7600701 BRO-B039(37) Replacement will be received at: Greene County, Missouri, Highway Department, 2065 N. Clifton Avenue, Springfield, Missouri 65803, until 2:00 o'clock P.M. (Prevailing Local Time) on the 28TH day of August, 2018, at the office of the Greene County Highway Department Conference Room, 2065 N. Clifton Ave., Springfield, Missouri, and at that time will be publicly opened and read. All bids shall be submitted as a Hard Copy.

The proposed work includes:

Demolition of existing bridge and construction of a new two span prestressed I-Girder Bridge. Approximately 356 feet of asphalt roadway and any incidental work in accordance with the plans and specifications. The project is located in Section 19, Township 30N, and Range 23W in Greene County, Missouri. The total length of the improvements along the centerline of Farm Road 76 is approximately 550 feet.

Plans and specifications will be provided by a CD. Bidders must print their own plan sheets and specifications from the DC in order to submit a bid. Plans and specification may be picked up from the Greene County Highway Department, 2065 N. Clifton, Springfield, MO 65803, telephone (417) 831-3591 upon payment of \$25.00. For plans and specifications mailed to bidders \$25.00 will be added for postage and handling or the bidder may provide a FedEx account number. Purchase and postage amounts are nonrefundable. The Greene County Highway Department assumes no liability for ensuring that documents mailed or shipped will arrive in time for bid preparation. All bidders must purchase plans through Greene County Highway Department and be on their planholder list in order to bid the project.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the United States Department of Labor (Federal Wage Rate), or by the Missouri Department of Labor and Industrial Relations (State Wage Rate), whichever is higher.

The Greene County, Missouri hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award. **The DBE Goal for this project is 8%.**

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2016 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works projects shall provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

The Greene County, Missouri reserves the right to reject any or all bids.

The project will be awarded to the lowest, responsive, responsible bidder.

No 2nd tier subcontracting will be allowed on this project.

No bidder may withdraw their bid within 90 days after the actual date of the opening thereof.
