

## **INVITATION TO BID**

and endorsed "Proposal" for constructing Project BRO-B097 (48), 230<sup>th</sup> Road, Saline County, Missouri, will be received by the Saline County Commission until 11:00 a.m, Daylight Savings Time, on the 16<sup>th</sup> day of May, 2017, at the office of the Saline County Commission, Saline County Courthouse, Saline County Courthouse, 19 East Arrow Street, Marshall, MO 65340, and at that time will be publicly opened and read.

The proposed work includes:

**Grading, constructing a 90' single span concrete I-girder bridge and a gravel surface 24 feet wide, together with any incidental work on 230<sup>th</sup> Road approximately 4.5 miles southeast of Marshall on Highway 41, thence 0.5 mile east on 225<sup>th</sup> Road; thence 0.5 mile north on Neon Avenue; thence 1 mile east on 230<sup>th</sup> Road to the bridge. The total length of the improvement is 850 feet.**

Bids must be submitted on proposal blanks attached to the Specifications or copies of same and be accompanied by Bidder's Certified Check or Bid Bond in the amount of 5 percent of bid.

The prime contractor must have a fully responsive contractor questionnaire on file with the Missouri Highway and Transportation Commission at least seven (7) days prior to the bid opening date.

Payment for this work under this Contract will be made in cash and the Owner reserves the right to reject any and all bids or waive irregularities.

The wage rates applicable to this project have been predetermined as required by law and are set forth in the bid proposal. When the Federal wage rates are applicable and included, this contract is subject to the "Work Hours Act of 1962," (P.L. 87-581:76 Stat. 357) and implementing regulations.

OSHA Ten Hour Training Requirements: Missouri Law, 293.675 RSMO, requires any awarded contractor and its subcontractor(s) to provide a ten-hour Occupational and Safety and Health Administration (OSHA) Construction Safety Program (or a similar program approved by the Missouri Department of Labor and Industrial Relations as a qualified substitute) for their on-site employees.

The Saline County Commission hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

The project will be awarded to the lowest, responsive, responsible bidder.

The DBE Goal for this project is 6%.

The OJT Goal for this project is 0 hours.
