INVITATION TO BID

Sealed bids for **CITY OF WEST PLAINS, MISSOURI – PORTER WAGONER BOULEVARD SIDEWALK PHASE 2** will be accepted at the City of West Plains, 1910 Holiday Lane, West Plains, MO 65775, until 2:00 pm February 7, 2018, and then publicly opened and read aloud at that time. Bids received after 2:00 pm will be returned unopened.

A **Mandatory** Pre-Bid meeting is scheduled for January 31, 2018 at 2:00 pm at 1910 Holiday Lane, West Plains, MO 65775.

This project will construct new sidewalks on the West side of Porter Wagoner Boulevard from Gibson Avenue South to Broadway and continue to the North side of Broadway along Porter Wagoner Boulevard.

The proposed sidewalks will be 5 ft wide in accordance with ADA.

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2017 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The City of West Plains hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award. *The project will be awarded to the lowest, responsive, responsible bidder.*

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.


A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.
