

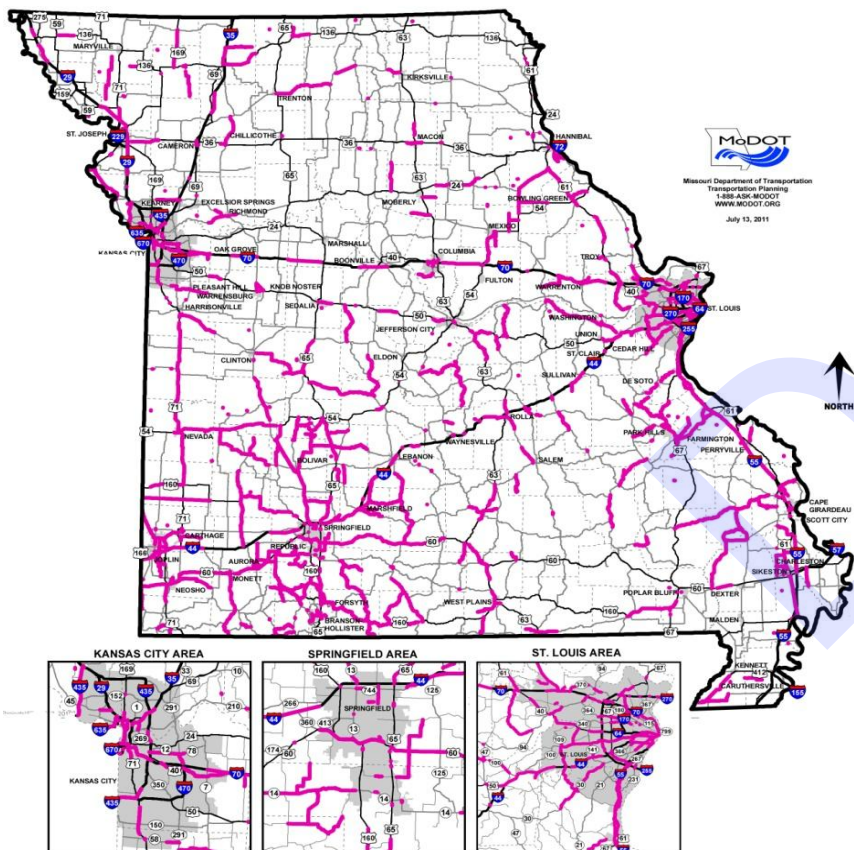


ECONOMIC IMPACT ANALYSIS FOR MISSOURI STATEWIDE TRANSPORTATION IMPROVEMENT PLAN

2012-2016 STIP PROJECTS



Missouri's Statewide Transportation Improvement Plan (STIP) invests over \$4.5 billion dollars in more than 980 transportation infrastructure projects across the state between fiscal years 2012-2016.

Over 20 years, every dollar of STIP highway investment in this project returns:
 \$0.06 in new net general revenues to the State of Missouri totaling \$281.8 million
 \$1.61 in new personal income to Missourians totaling \$7.3 billion
 \$2.42 in new value-added (GSP) to Missouri's economy totaling \$11.0 billion
 \$3.74 in new economic activity (output) to Missouri's economy totaling \$17.0 billion

Over 20 years, the project creates an average of 8,786 new jobs paying an average wage of \$27,773 per job, generates \$14.1 million in new net general revenues annually, \$366.4 million in new personal income annually, \$550.0 million in new value-added to the economy annually, and \$850.2 million annually in new economic activity.

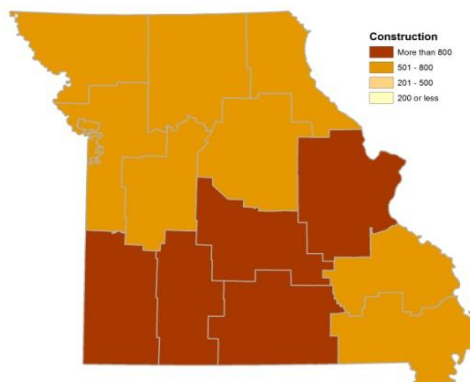

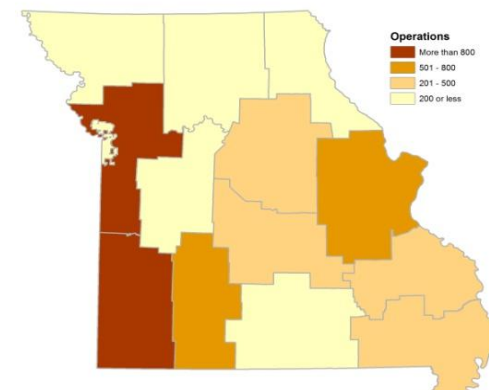
CONSTRUCTION PHASE

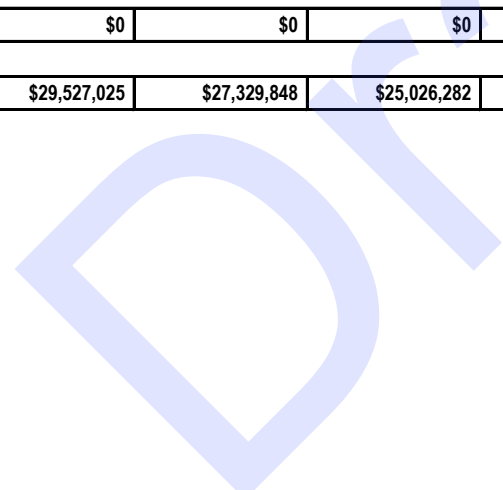
