

## **Transit Grants Award Notice**

### **FFY 2010 & 2011 JARC Grants Award Notice**

The Missouri Department of Transportation's Transit Section announces the awarding of grants under the Federal Transit Administration's Job Access and Reverse Commute (JARC) Transportation Program – (49 USC Section 5316 – CFDA 20.516).

Four organizations were awarded grants with FFY 2010 and FFY 2011 funding for operating expenses under the Job Access and Reverse Commute Program. The funding for Small Urbanized Areas went to the City of St. Joseph - \$369,371 as well as OATS, Inc. - \$360,000 for projects in Columbia and Jefferson City. The Nonurbanized (Rural) Area funding went to OATS, Inc. - \$1,670,038 for project in 16 counties and to Ray County Transportation - \$189,350 for a project in Ray County.

### **FFY 2012 JARC Grants Award Notice**

The Missouri Department of Transportation Transit Section announces the awarding of grants under the Federal Transit Administration's Job Access and Reverse Commute (JARC) Transportation Program (49 USC Section 5316 – CFDA 20.516).

Three organizations were awarded grants with FFY 2012 funding for operating expenses under the Job Access and Reverse Commute Program. The funding for Small Urbanized Areas went to the City of St. Joseph - \$216,333 as well as OATS, Inc. - \$151,559 for projects in Columbia and Jefferson City. The Nonurbanized (Rural) Area funding went to OATS, Inc. - \$762,888 for project in 16 counties and to the Cape Girardeau County Transit Authority - \$116,500 for a project in the Cape Girardeau county area. The Cape Girardeau County Transit Authority also was awarded \$69,360 in capital funding for the purchase of two transit vehicles.

### **FFY 2010 New Freedom Grants Award Notice**

The Missouri Department of Transportation's Transit Section announces the awarding of grants under the Federal Transit Administration's New Freedom Program (49 USC Section 5317 – CFDA 20.521).

Two organizations were awarded grants with FY 2010 funding under the New Freedom program for providing transportation beyond ADA requirements: Jefferson County Community Partnership - \$517,689, and the City of Jefferson - \$32,000. The grants were awarded for operating expenses - \$354,102, vehicle acquisition - \$163,578 and bus shelters programs - \$32,000.

### **FFY 2011 & 2012 New Freedom Grants Award Notice**

The Missouri Department of Transportation's Transit Section announces the awarding of grants under the Federal Transit Administration's New Freedom Program (49 USC Section 5317 – CFDA 20.521).

Five organizations were awarded grants with FFY 2011 and FFY 2012 funding under the Federal Transit Administration's New Freedom program for providing transportation beyond ADA requirements: Services for Independent Living – \$766,669, Jefferson County Community Partnership - \$264,329, Texas County Memorial Hospital - \$93,984, Ray County Transportation - \$68,000, Boonslick Regional Planning Commission - \$197,408. Grants were awarded for operating expenses - \$797,872 vehicle acquisition - \$161,984 and mobility management programs - \$430,081.
