

## BID FOR PURCHASE OF LAND

Each bidder must submit funds equaling 10% of the bid amount (shown below) as a down payment. Funds should be a cashier's check or money order made payable to **"DIRECTOR OF REVENUE-CREDIT STATE ROAD FUND"**. All unsuccessful bidders will have the 10% down payment returned to them (uncashed) by mail. **PLEASE NOTE: ONLY THE DOWN PAYMENT MONIES ARE DUE – NOT THE FULL AMOUNT OF THE BID.**

The successful bidder will be required to submit the 10% down payment and within 5 days sign a sales agreement. The deposit will not be refunded if the sale is not completed through no fault of the Missouri Highways and Transportation Commission. Possession of the property will be within sixty-(60) days after bid opening and final payment is expected upon delivery and recording of the deed from the commission. Recording and applicable fees will be the responsibility of the buyer. Final payment, like the down payment will be in the form of a cashier's check or money order made payable to **"DIRECTOR OF REVENUE – CREDIT STATE ROAD FUND"**.
