LANE RESTRICTIONS FOR THE WEEK OF MAY 12, 2008

MADISON COUNTY

I-55 and I-70 Lane restrictions will be encountered along westbound Interstate 70, at mile marker 17, and along southbound I-55, at mile marker 22. These lane restrictions are necessary for electronic message sign construction. These lane closures will only be necessary to perform work over or near the roadway. No lane closures will be allowed during peak hours, which are 6:00 a.m. to 9:00 a.m., and all work should be completed by May 16, 2008, weather permitting.

I-55/70 & I-255/55/70 Lane restrictions will be encountered along westbound I-55/70 between IL Rte. 111 (mile marker 8) and IL Rte. 157 (mile marker 11) and at the I-255/55/70 interchange. These lane restrictions are necessary for milling and pavement resurfacing. These restrictions are anticipated to continue until May 16, 2008.

I-255 I-255/270 Lane restrictions will be encountered along northbound and southbound I-255 between IL Rte. 162 (mile marker 29) and I-270 (mile marker 31) and at the I-255/270 interchange ramps listed below.
I-255 northbound to I-270 eastbound and westbound
I-255 southbound to I-270 westbound
I-270 eastbound to I-255 southbound
These lane restrictions are necessary for milling and pavement resurfacing.
These restrictions are anticipated to continue until June 6, 2008.

I-255/I-55/70 Ramp work in the I-255 and I-55/70 interchange may be encountered and continue through the end of May, 2008, weather permitting, to patch the pavement. The ramps are from:
I-255 northbound to I-55/70 eastbound and westbound
I-255 southbound to I-55/70 eastbound and westbound
I-55/70 eastbound to I-255 northbound and southbound
I-55/70 westbound to I-255 northbound and southbound

IL 3 Intermittent lane closures on IL 3 in Godfrey and Alton will occur at the following three locations: from Pierce Lane to West Delmar, from Godfrey Road to Alby Street, and from Bloomer Drive to North Rodgers. These lane closures are necessary to patch and resurface the pavement. It is estimated that the project will be completed by the end of July.

IL 111 Intermittent lane restrictions will be encountered along northbound and southbound IL 111 at I-55/70. These lane restrictions are necessary for painting

the structure carrying I-55/70 over IL 111. Work on this project is expected to be completed by August 15, 2008.

- IL 140** Lane restrictions will be encountered on IL 140 from Brakane Road to Quercus Grove Road near Carpenter. These lane restrictions are necessary for shoulder removal and replacement and flashing beacon installation. The work on this project is expected to be completed by June 30, 2008.

- IL 140** One lane of IL 140 will be closed approximately 4 miles west of Hamel. Two-way traffic will be guided through the work zone using temporary traffic signals and traffic control signing. The lane closure is necessary to reconstruct the existing bridge carrying IL 140 over Cahokia Creek. Work is expected to be completed by late Fall, 2008.

- IL 143** A lane closure and width restriction with stage construction and temporary traffic signals will be encountered on Illinois Route 143, northwest of Highland at the Highland Lake spillway structure in Highland. Construction activities are anticipated to be completed by July 31, 2008. The lane closure is needed to repair the Low Level Outlet Works Structure in Highland Lake.

- IL 143** One lane of IL 143 will be closed approximately 3 miles west of IL 4, east of Edwardsville. Two-way traffic will be guided through the work zone using temporary traffic signals and traffic control signing. The lane closure is necessary to reconstruct the existing bridge carrying IL 143 over Silver Creek. Work is expected to be completed by the Summer of 2008.

- IL 159** Lane closures may be encountered on Illinois Route 159 south of Knab Road, south of Smithton. Construction activities are anticipated to be completed by May 15, 2008. The lane closures are needed to construct a southbound left turn lane, intersection improvements, and drainage improvements for the Ledgestone Estates Subdivision.

- IL 162** Periodic lane closures may be encountered for the five lane construction of IL 162 from east of I-55/70 to U.S. Rte. 40 in Troy. The work will include widening and resurfacing IL Rte. 162 to five lanes from Formosa Road to west of downtown Troy, milling and resurfacing IL Rte. 162 in downtown Troy, and resurfacing, shoulder widening, and drainage improvements on IL Rte. 162 from North Dewey Road to U.S. Rte 40. This work is expected to be completed and ready for traffic by the Summer, 2008.

IL 255 Lane restrictions may be encountered in the northbound lanes along IL 255 at the intersection with IL143. Work is scheduled to be completed by May 16, 2008. These lane restrictions are needed to begin work for an overhead sign structure.

ST. CLAIR COUNTY

Piggott Ave. Ramp The ramp from Piggott Avenue onto eastbound I-55/70/64 will be closed for deck repairs utilizing the marked Seventh Street detour in St. Louis, Missouri. This ramp is expected to be completed and opened by October 31, 2008. The project consists of replacing the existing concrete deck overlay and performing structural steel repairs to the bridge. Marked detours will be established to aid the motorists during this ramp closure.

IL 13/15 Motorists traveling on Illinois Route 13/15 will encounter lane shifts east of Green Mount Road. These lane shifts are necessary to move traffic to portions of the newly constructed lanes so that the construction of a four lane divided highway can advance to the next stage. Intermittent daytime lane closures will still be in effect on Illinois Route 13/15 from Green Mount Road to Rogers Drive in Freeburg. The project is expected to be completed by the Fall of 2008.

IL 13/157 The intersection of Illinois 13/157 will be under construction. A marked detour utilizing Illinois Routes 163 and 15 will be in place to move traffic around the closed section of Illinois 13/157 west of the intersection. The required work includes the removal of the existing intersection and constructing a new roundabout in Centreville. Work should be completed by June 1, 2008.

IL 13/157 Illinois 13/157, over Harding Ditch just southeast of the junction of Illinois Route 13/157, will be closed. A marked detour utilizing Illinois Routes 163 and 15 will be in place to move traffic around the closed section. The required work includes the removal and replacement of two bridges and the project is expected to be completed by the Spring of 2008.

IL 159 Lane closures may be encountered on Illinois Route 159 north of Frank Scott Parkway in Fairview Heights. Construction activities are anticipated to be completed by July 31, 2008. The lane closures are needed to construct a southbound right turn lane, intersection improvements, and drainage upgrades for the Target Development.

IL 177 Lane reductions will be encountered along IL 177 from McClintock Avenue to IL 158. These daytime only closures will utilize flaggers to maintain two-way traffic during construction. Work is necessary to repair and resurface the existing roadway and is expected to be completed by June 30, 2008.

CLINTON COUNTY

OLD U.S. 50 The bridge carrying Old U.S. Route 50 over Sugar Creek will be closed to traffic. This closure is necessary to completely remove and replace the structure approximately 1 mile west of Aviston. A marked detour route will be in place to guide traffic around the closure utilizing Russland Street to New U.S. Route 50 to Illinois Route 160. Old U.S. Route 50 is expected to be re-opened to traffic no later than December 1, 2008.

RANDOLPH COUNTY

IL 3 There will be intermittent daytime lane closures on Illinois Route 3 from Riverview Boulevard in Chester to the Randolph/Jackson County line. These lane closures are necessary to patch and resurface the pavement. Please watch for stopped traffic and allow extra time when traveling through the work zone. The work should be completed by the Fall of 2008.

WASHINGTON COUNTY

I-64 Lane restrictions will be encountered along eastbound and westbound Interstate 64 from 1 mile west of U.S. Route 51 to the Jefferson/Washington County line (mile marker 60 to 62). Lane restrictions will be in place during both daytime and nighttime hours, weather permitting. These lane restrictions are necessary to perform bridge repairs, and work is expected to be completed by November 15, 2008.
