## **ECONOMIC IMPACT ANALYSIS**

## **Highway 50 Expansion**

The Highway 50 Expansion Project will expand 109 miles of roadway to four lanes along the current U.S. 50 Route. The project investment will be \$840 million dollars and will take approximately five years to complete.

Over 20 years, every dollar of investment in this project returns:

\$0.07 in new net general revenues to the State of Missouri totaling \$60.8 million

\$1.45 in new personal income to Missourians totaling \$1.2 billion

\$2.63 in new value-added (GSP) to Missouri's economy totaling \$2.2 billion

\$4.29 in new economic activity (output) to Missouri's economy totaling \$3.6 billion

On average each year, the project creates 1,550 new jobs annually paying an average wage of \$29,319 per job, generates \$3.0 million in new net general revenues annually, \$61.1 million in new personal income annually, \$110.3 million in new value-added to the economy annually, and \$180.2 million annually in new economic activity.

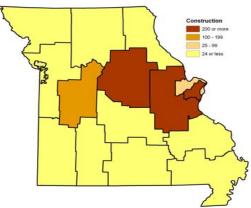

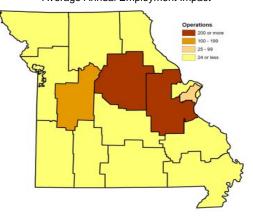
#### **CONSTRUCTION PHASE**

#### **ASSUMPTIONS**

Engineering costs of \$110 million. Gain of \$110 million in Professional Technical Services industry in CY 2010-2014.

Right of Way costs of \$50 million. Gain of \$3 million in Real Estate industry from transaction fees in CY 2010-2014.

Construction costs of \$680 million. Gain of \$680 million in Construction industry in CY 2010-2014.

Production Cost Impact: Average business production costs savings of 0.03% per year in CY 2015-2034. Cost savings derived from FHWA production cost factors scaled to current time period, industry mix, type of project, regional output and transportation costs.

Project Investment/Costs: MoDOT costs of \$840 million split into 80% federal funds and 20% dedicated general revenue funds.

Impacts occur in Greater St. Louis, Central, and West Central Missouri. Assumptions provided by DED. Estimated using REMI-9-Regional Model (remi-fiscal-9-jun07).
