STATEWIDE TRANSPORTATION IMPROVEMENT PROGRAM (STIP).

4. **Request for Approval of Location and/or Design of Highways.** Consideration for the following roadways location and/or design.

Route 364 in St. Charles County.

The proposed improvements provides for a new interchange on Route 364 at Gutermuth Road and includes installation of on and off ramps and acceleration and deceleration lanes on Route 364. Roundabouts will be installed at the ramp termini on Gutermuth Road. Work includes Grading, Paving, Drainage, Lighting, Signing, Retaining Walls, Soundwalls, and Bridge widening. This is a collaboratively funded project with funding provided by MoDOT, St. Charles County, and the federal government through East West Gateway. *Tom Blair, St. Louis District Engineer*

Route 180 in St. Louis County.

The proposed improvement is to resurface roadway and upgrade existing sidewalk along the corridor to meet Americans with Disabilities Act (ADA) requirements. Implement a lane reduction (four lanes to three lanes) along MO 180 between Normandy Avenue and the St. Louis City limits to increase safety for all modes of travel. The roadway typical will consist of 11-foot lanes and five foot shoulders.

Route I-44 in Webster County.

The proposed improvement provides a new interchange on Interstate 44 at mile marker 103 and the realignment of Route CC from approximately Rifle Range County Road west to Interstate 44. The new lane widths on Route CC will be 12 feet. The new ramps will be variable width and a minimum of 12 feet. Curb and gutter sections will be constructed on Route CC in and around the interchange. A multi-use path will be constructed along Route CC from the west side of Interstate 44, east to Elm Street and on Elm Street. Elm Street is a City Street that is being designed with the project and will be placed as an add alternate bid in the contract.
