## MINUTES OF THE REGULARLY SCHEDULED HIGHWAYS AND TRANSPORTATION COMMISSION MEETING HELD IN JEFFERSON CITY, MISSOURI, WEDNESDAY, MARCH 5, 2014

A regularly scheduled meeting of the Missouri Highways and Transportation Commission was held on Wednesday, March 5, 2014, at the Missouri Department of Transportation Building, 105 West Capitol Avenue, Jefferson City, Missouri Stephen R. Miller, Chairman, called the meeting to order at 1:00 p.m. The following Commissioners were present: Lloyd J. Carmichael, Kenneth H. Suelthaus, and Gregg C. Smith. On February 6, 2014, Governor Nixon withdrew the appointment of Commissioner Kelley M. Martin; at the time of the March 5, 2014 meeting, a replacement had not been appointed. Also on February 6, 2014, Governor Nixon withdrew the appointment of Commissioner Bryan T. Scott; at the time of the March 5, 2014 meeting, Commissioner Scott had been reappointed but not yet confirmed.

The meeting was called pursuant to Section 226.120 of the Revised Statutes of Missouri, as amended. The Secretary verified that notice of the meeting was posted in keeping with Section 610.020 of the Revised Statutes of Missouri, as amended.

Dave Nichols, Director of the Missouri Department of Transportation; Rich Tiemeyer, Chief Counsel for the Commission; and Pamela J. Harlan, Secretary to the Commission, were present on Wednesday, March 5, 2014.

"Department" or "MoDOT" herein refers to Missouri Department of Transportation. "Commission" or "MHTC" herein refers to Missouri Highways and Transportation Commission.

The Chairman and Secretary to the Commission were authorized and directed to sign and certify said minutes and to file same in the office of the Secretary.

#### **CONSENT AGENDA**

#### **Consent Agenda Process**

In order to make the most efficient use of Commission meeting time and to ensure Commission members are well informed on issues requiring their action, staff prepares and submits to the Commission members, in advance of their meeting, internal memoranda consisting of advice, opinions, and recommendations related to the items of the Commission meeting agenda. Those items considered by staff to be of a routine or non-controversial nature are placed on a consent agenda. During the meeting, items can be removed from the consent agenda at the request of any one Commission member. The items that are not removed from the consent agenda are approved with a single motion and unanimous vote by a quorum of the members.

Minutes reflecting approval of items on the consent agenda are singly reported herein and intermingled with minutes reflecting action on related subjects that were openly discussed. Reference to "consent agenda" is made in each minute approved via the process described in the paragraph above. Minutes reflecting action on items removed from the consent agenda and openly discussed reflect the open discussion and vote thereon.

#### Consideration of March 5, 2014, Consent Agenda

No items were removed from the consent agenda. Upon motion by Commissioner Carmichael, seconded by Commissioner Smith, the consent agenda items were unanimously approved by a quorum of Commission members present. Commissioner Carmichael abstained from Consent Agenda item number 6, Recommendation to Extend Willow Springs Agreement.

### **COMMISSION COMMITTEES AND COMMISSION RELATED BOARDS**

The Commission has two standing committees: Audit and Legislative. In addition, it elects Commission representatives to two boards: Missouri Transportation Finance Corporation Board of Directors and MoDOT and Patrol Employees' Retirement System Board of Trustees. The following committee and board reports were made during the March 5, 2014, meeting.

Audit Committee – Commissioner Suelthaus stated the audit committee met earlier in the morning and reviewed two internal audit reports and concurred with the recommendations made in the following audits (1) Review of Construction Contract Administration – Kansas City, Northwest, and Central Districts, and (2) Review of Highway Safety – DWI Enforcement Grants – Kansas City District. Commissioner Suelthaus also noted the committee discussed the current audit being conducted by the State Auditor's Office.

**Legislative Committee** – Commissioner Carmichael stated House Joint Resolution (HJR) 68, which is the one cent sales tax for transportation, has been of great interest to the Commission. HJR 68 awaits floor debate by the House, but the legislative committee is very optimistic that it may be debated by the House by the end of the month. Commissioner Carmichael noted if HJR 68 moves forward in the House, it will proceed to the senate.

Missouri Transportation Finance Corporation – Commissioner Miller stated there was no report.

**MoDOT and Patrol Employees' Retirement System** – Commissioner Suelthaus stated the Board met on February 27, 2014 and took action to extend the contract for the actuary, Gabriel, Roeder, Smith & Company. He reported the total assets of the fund have now reached about \$1.8 billion, and Commissioner Carmichael was elected Chair and Colonel Ron Replogle as Vice Chair of the Board.

### **DIRECTOR'S REPORT**

During the March 5, 2014, Commission meeting, Director Dave Nichols provided the following report:

**Snow Removal** – Director Nichols provided another story of Team MoDOT being responsive and keeping the roads safe. The Southeast District received twelve inches of snow and staff were responsive. Director Nichols remarked how proud he was of Team MoDOT on snow removal and the winter operations process.

**Pothole Patrol** – Director Nichols commented the weather will begin to warm up and when the pavement starts thawing is when potholes will be created. In anticipation of potholes, the department is implementing a program for Missourians to alert the department if they see a pothole or identify one. This way Team MoDOT can fix potholes as they are reported as that is a core part of our business and the department wants to keep roads safe. Missourians can contact the department via email or they can call 1-888-ASK-MODOT.

**Washington DC** – Director Nichols provided a brief update on the AASHTO legislative briefing in Washington, D.C. There was a lot of discussion about transportation funding issues at the state level, but there are also transportation funding challenges at the federal level. All fifty department of transportation representatives were present; there were round table discussions along with presentations from leadership in Congress on the various transportation committees. Senator Barbara Boxer, chair of the Senate Environmental Public Works Committee, talked to the group about transportation issues as she is very well aware of the federal funding issue. US Department of Transportation Secretary Anthony Foxx also met with the group to discuss the possibility of the trust fund becoming insolvent. Director Nichols stated all state departments of transportation are concerned about the funding issue. Last week, the President unveiled an opportunity to infuse money over the next four years for transportation funding at the federal level, which is being discussed and analyzed.

Act of Heroism – Director Nichols shared the story of an extraordinary effort and act of heroism. On February 10, 2014, Micah Lasley was plowing his route and noticed a home burning off Route Z in Calwood. An elderly man was standing in freezing cold temperatures in his front yard, and looked very distressed. Mr. Lasley was concerned so he stopped to check on the man and found that the elderly man's wife was in distress too. Mr. Lasley helped make sure the couple was safe, called 911 for them, and stayed with the couple until emergency personnel arrived. Director Nichols thanked him for his life saving actions during this emergency.

#### THE DETERIORATING CONDITION OF STATE BRIDGES

Dennis Heckman, State Bridge Engineer, recalled it has been almost seven years since the collapse of the I-35W Bridge in Minneapolis. When those individuals left for work that day, they gave no thought to the bridge under their cars; they trusted it would be ok. Missourians expect the same. Now that the long range transportation plan has been reviewed and approved, it is clear that Missourians have four goals, which includes taking care of the current system, keeping all travelers safe no matter the mode, investing in projects that spur economic growth and create jobs, and give Missourians better transportation choices.

Mr. Heckman discussed bridges and how to take care of bridges. It takes continuous investment starting early in the life of a bridge for things such as preventive maintenance, like washing off the deck, sealing the decks, and painting steel before it rusts too badly. All of these types of maintenance help extend the life of the bridge. The longer the life can be extended, the longer the more costly work of replacement or major bridge rehabilitation can be prolonged. Eventually, every bridge will need to be rehabilitated or replaced, but the more the department can invest in taking care of the current system, the longer the bridges will last.

Mr. Heckman noted bridges continue to age. The department has talked about how the number of poor bridges has decreased by 800 in the last five years, but the number of good bridges did not increase by 800, as most are in the fair category. The average age of the 10,000 plus state bridges is forty-five years and unfortunately most were designed for fifty years. It takes a lot of maintenance work to keep the bridges in their current condition.

Mr. Heckman explained the data that when bridges are inspected, a code is given to each piece of the bridge from zero to nine. For example, nine is brand new like the Stan Musial Veterans Memorial Bridge in St. Louis and zero for a failed bridge. When a bridge scores in the three to four range is when discussions begin about closing a bridge. The Safe and Sound bridge program made major investments in bridges, but another 1,600 bridges deteriorated in the timeframe of the program. Another 1,600 improved slightly, going from bad to fair. Mr. Heckman stated the bottom line is even with major investments, due to the age of our bridge system, the department is just treading water.

The stark reality is bridges will suffer just like the rest of the system without additional funding. As the size of the construction program drops, approximately 120 bridges per year drop into the poor category so the number of poor bridges will increase rapidly. Mr. Heckman noted more bridges will need to be weight restricted which is something the department takes very seriously. All bridges are evaluated to determine if weight restrictions need to be imposed; poor bridges have to be inspected more often to keep a close eye on the bridge condition. As bridge conditions deteriorate, more bridges will have to be closed; currently, the department takes every measure to open a closed bridge as quickly as possible or even replace the bridge when necessary. However, with limited funds, keeping bridges open and free from weight restriction will be harder to accomplish. The stark reality is, economic development and mobility will suffer with more bridges being weight restricted or closed.

Following a discussion about bridge quality, replacement, and deterioration, Commissioner Miller thanked Mr. Heckman for his presentation and for highlighting the continuing need for bridge repairs and replacement.

## PUBLIC COMMENT – SHAWN ARCHAMBAULT

Shawn Achambault, One Curve at a Time, reminded the Commission of the loss of his twenty year old daughter, Kaela Marie Archambault. On the morning of November 18, 2010, Kayla died on of the curves on Highway FF in Jefferson County. Mr. Achambault stated neither he nor anyone else in the room could have changed or stopped her from hitting a school bus that day. As he shared with the

Commission on December 7, 2011, when he spoke for his daughter and for those would could not speak for themselves, he began the healing process.

Mr. Achambault stated it would be a dishonor to his daughter and many others if nothing was done. A change had to be made. One Curve at a Time started approximately two years ago and their mission is simple – One Curve at a Time is a non-profit organization dedicated to building awareness about and making changes to dangerous roads and curves that keep killing loved ones. With a growing number of volunteers, One Curve at a Time focuses on educating the public about critical road problems, working with local law enforcement to enhance accountability for safe driving, and advocating for engineering and other solutions so that these problem areas along roadways and curves are addressed.

Mr. Achambault remarked today is a new date that has been added along with Kayla's birth date, heaven date, and now impact date of change, March 5, 2014. This date will allow Kayla to continue to impact how we look at curves and shoulders and the life changing differences that will happen for many others that drive Missouri's roads in the future. With the approval of the bids at the Commission meeting today, the Commission approved improvements to Highway FF in Jefferson County.

Mr. Achambault recognized individuals he trusts to make the right decisions on a daily basis – Director Dave Nichols, Chief Engineer Ed Hassinger, and District Engineer Greg Horn, and heart of gold Area Engineer of Jefferson and Franklin County Judy Wagner. Mr. Achambault stated there are many others but time is short to recognize MoDOT's entire long list of great people who have made a great difference. Mr. Archambault extended an invitation for all to attend One Curve at a Time's ground breaking ceremony on Highway FF in Tall Oaks in Jefferson County on April 26, 2014 at 9:00 a.m.

Commissioner Miller thanked Mr. Archambault for his comments and for reminding the Commission how important their work is. Commissioner Suelthaus commented that every parent certainly understands the difficultly in this, and commended him for doing something positive as a result of his loss.

## **COMMISSION POLICY REVISION – EMPLOYEES – MEDICAL AND LIFE INSURANCE**

In keeping with the Commission's February 11, 2014, action pertaining to participation in the

cost of medical insurance coverage for employees and retirees, Roberta Broeker, Chief Financial

Officer, recommended that the Commission's policy related to this subject be updated as follows:

# Category:EMPLOYEESSubcategory:Compensation, Insurance, Retirement, and Credit Unions

## MEDICAL AND LIFE INSURANCE

As allowed under Sections 104.270 and 104.1072, RSMo 2000, as amended, a Medical and Life Insurance Plan has been established for employees, retirees, and deferred annuitants of the MoDOT and Patrol Employees' Retirement System (MPERS) and their dependents. A Commission-appointed Board of Trustees administers the Medical and Life Insurance Plan in keeping with the Board guidelines approved by the Commission.

- The Commission currently subsidizes the cost for the employees, retirees, disability recipients, survivors of employees and retirees, and spouses and/or dependents of employees and retirees.
- The Commission approves the employer contribution to the Medical and Life Insurance Plan. The contributions are subject to the financial resources deemed by the Commission to be appropriate for this employee benefit and the Commission's financial situation. Effective January 1, 2015, and extending until such time as the Commission determines it to be prudent to increase or decrease its share of the total medical insurance plan premium, the following percentages of employer participation will apply:
- •
- Active employees and Work Related Disability Recipients (all rate categories): 80 percent.
- **Retirees who retire on or after January 1, 2015**: Two percent per full year of creditable service in the retirement system capped at 50 percent. The percentage will be applied to the premium applicable to the rate category in which the retiree is enrolled.
- **Retirees who retired or will retire prior to January 1, 2015**: Employer percentage of total premium will be the same percentage in effect for calendar year 2014, as shown below.

- Each rate group (Active, Non-Medicare Retiree, Medicare Retiree) shall be self-sustaining.
- Permanent part-time employees (those whose work is anticipated to exceed 1040 hours annually) of the Department, Patrol, or MPERS who are members of MPERS may participate in the Plan.
- Any employee terminating employment with the Department, Patrol, or MPERS who is a vested member of MPERS and who is a participant in the Medical Insurance Plan immediately prior to termination may retain continuous medical insurance coverage in keeping with the provisions of the Plan by paying the entire cost thereof. Commission subsidies will not be provided. Employees terminating employment who are not participants in the Medical Insurance Plan at the time their employment ends or who after their employment ends allow their coverage to lapse will not be permitted to reacquire coverage through the Medical Insurance Plan. Former employees who regain employment are entitled to coverage in the Medical Insurance Plan.
- Benefit provisions are in keeping with the most current Medical and Life Insurance Plan document.
- An open enrollment period will be offered to employees every two years.
- Employee questions regarding the Medical Insurance Plan are to be directed to employees whose job specifications include advising employees regarding employee benefits.

Via approval of the consent agenda, the Commission unanimously approved the revision to the

Medical and Life Insurance Policy described above.

# MISSOURI TRANSPORTATION FINANCE CORPORATION (MTFC) – ELEVENTH AMENDED AND RESTATED BYLAWS

On behalf of the Board of Directors of the Missouri Transportation Finance Corporation (MTFC),

and the MoDOT Director, Brenda Morris, Financial Services Director, presented proposed revisions to

the Tenth Amended and Restated Bylaws of the Missouri Transportation Finance Corporation. The

proposed revisions will provide consistency with the Commission's policies and the Corporation's

Articles of Incorporation. The revisions, as summarized below, were approved by the MTFC Board of

Directors at its February 11, 2014, meeting.

- Article III, Board of Directors, will be amended to clarify that the Commission selects, either by election or MoDOT title designation within the bylaws, all members of the MTFC Board of Directors.
- Article V, Officers, will be amended to reflect that the Chairman of the Commission will be responsible for appointing one of the three current Commission members elected by the Commission to serve on the MTFC Board of Directors as President of the MTFC Board of Directors.
- Article VI, Executive Director, will amend the timeframe from 60 days prior to the end of the fiscal year to 45 days prior to the end of the fiscal year for the Executive Director to submit a proposed annual budget to the MTFC Board of Directors.
- Article VIII, Amendments, will be amended to reflect that bylaws amendments or new bylaws must be approved by both the Board of Directors and the Commission.

Via approval of the consent agenda, the Commission unanimously approved the amended MTFC

Bylaws as described above.

## CONSIDERATION OF BIDS FOR ROADWAY IMPROVEMENTS

On behalf of the Director, Eric Schroeter, State Design Engineer, presented the following recommendations pertaining to bids received on federal-aid and state highway and bridge projects during the past month.

Mr. Schroeter recommended (1) Award of contracts to the lowest responsive bidders for bids received at the February 21, 2014, letting, as recommended and noted in Table I below. (2) Rejection of bids received on Call CO4, as noted in Table II below, due to the bids being excessive per Section 102.15 of the Missouri Standard Specifications for Highway Construction. (3) Declare the bid by Bloomsdale Excavating Company, Incorporated for Call B02 as non-responsive per Section 102.8 of the Missouri Standard Specifications for Highway Construction due to not providing a bid guaranty with their bid. (4) Declare the bid by Phillips Hardy, Inc. for Call B02 as non-responsive per Section 102.7 of the Missouri Standard Specifications for Highway Construction due to not completing bids in accordance with the bidding documents.

## **REQUEST FOR APPROVAL OF DESIGN OF HIGHWAYS**

## Route 94, St. Charles County Job No. J6P2330 Public Hearing Held January 22, 2014

The proposed improvement provides raising the grade of Route 94 by three and a half feet and adding two foot shoulders. The project will have normal access right of way. Route 94 will be closed to all but local traffic for a period of four to six weeks while the road is being raised to the new grade. A signed detour will guide motorists to Route F and Schluersburg Road to get around the closure. The project is 0.7 miles in length.

On behalf of the Director, Greg Horn, St. Louis District Engineer, recommended approval of the

design as presented at the public hearing.

After full consideration of the favorable and adverse economic, social and environmental effects of the recommended designs, the Commission via approval of the consent agenda unanimously found and determined the recommended design would best serve the interest of the public and approved the recommendation.

#### **RECOMMENDATION TO EXTEND WILLOW SPRINGS AGREEMENT**

On behalf of the Director, Kelly Lucas, Right of Way Director, explained the Commission's November 7, 2013, policy regarding use of Commission-owned property or property rights authorizes staff to execute leases and agreements for use of real property and it appurtenances. However, the policy further requires that all unique, sensitive and/or controversial transactions be submitted to the Commission for consideration. The proposed supplemental agreement is unique because of the nature of the original agreement previously approved by Commission action.

On February 1, 2012, the Commission approved the execution of the initial Lease with Option to Purchase Agreement with the City of Willow Springs. The initial agreement was fully executed on March 30, 2012. The terms of the initial agreement required the City of Willow Springs to achieve economic development through the creation of new jobs and/or increase student enrollment at an institution of higher education generating tuition revenues within a ten year period in lieu of payment. To date, the City of Willow Springs has achieved \$20,520 toward the \$1,305,630 economic development goal established by the initial agreement.

The City of Willow Springs has requested a modification to the original agreements, which requires a reasonable progress goal to be met in year two of the original agreement. The modification requested by the City of Willow Springs would require a reasonable progress goal to be met in year three. The City will need to apply an additional \$80,930.40 toward the goal by March 30, 2015. The City has facilitated an agreement between Missouri State University and Three Rivers Community College to provide educational opportunities at the facility. The educational institutions have developed a recruitment plan to reach the goals established in the agreement.

Via approval of the consent agenda, the Commission unanimously authorized the Director, Chief Engineer, Chief Financial Officer, or Assistant Chief Engineer to execute the Lease with the Option to Purchase Amended Agreement to extend the reasonable progress requirement to year three (March 30, 2015).
