

## **Waste Tire Transporter Permit – Online Procedures**

All motor carriers who transport waste tires (tires that are no longer suitable for their intended purpose because of wear, damage, or defect) must obtain a Waste Tire Transporter Permit. A Waste Tire Transporter Permit can be requested by filling out a WT-1 form located on the Waste Tire Transporters tab of our website at [www.mcs.modot.mo.gov/mcs](http://www.mcs.modot.mo.gov/mcs), or online through MoDOT Carrier Express.

A Waste Tire Transporter Permit is valid for one year from the date of issuance.

MoDOT Motor Carrier Services is responsible for the administration of the Waste Tire Permitting Program, however all fees are transferred to and retained by the Missouri Department of Natural Resources. The DNR reviews and approves or denies each application for a Waste Tire Transporter Permit.
