NOTICE TO CONTRACTORS

Sealed bids for **STP-5200 (919)-ADA Accessibility Improvements—6th & Holloway-Rolla Project 448**, will be received at **901 North Elm Street-3rd Floor, Rolla, MO** until **11:00 o'clock A.M. on December 5, 2018**, at the **office of the City of Rolla City Clerk**, and at that time will be publicly opened and read. All bids shall be on the proposal form provided in the specifications and shall be accompanied by submittals and a bid bond issued by an acceptable surety company and payable to the order of the City of Rolla, for not less than five percent (5%) of the total amount of the bid.

The proposed work includes: **Construction of 32,808 sf sidewalk, 5,357 lf curb and gutter, 10,478 sf drive apron and the installation of 1,544 sf cast iron truncated domes. Contractor shall be responsible for, but not limited to, demolition of existing structures, construction of ramp and adjacent curb and sidewalk, incidental erosion control and landscaping.**

Plans and specifications may be picked up from the office of the City of Rolla Public Works Department at 901 North Elm Street-4th Floor. A non-refundable deposit of \$50.00 will be required. The specifications and plans will also be available for downloading at www.rollacity.org/bids.

A pre-bid conference will be held at **11:00 a.m. on November 28, 2018** at 901 North Elm Street-4th Floor in the Public Works Department. **All bidders are encouraged to attend the pre-bid meeting.**

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The City of Rolla hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award."

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A bid bond in the amount of five percent (5%) shall be submitted with each proposal.

The City of Rolla reserves the right to reject any or all bids.

The DBE Goal for this project is **four percent (4%)**.

No 2nd tier subcontracting will be allowed.
