Sealed bid #ST-08-181218-F-314 will be received at 401 South Jefferson, Lebanon, MO 65536, herein after called City Hall, until 2:00 p.m., on December 18, 2018 and then publicly opened and read aloud for construction of:

STP-3800(807) -Mill and overlay with hot asphalt on Springfield Road from Elm Street to 325 feet south of Commercial Street, approximately 2595 total linear feet.

Plans and specifications may be picked up from the office of Lebanon Public Works at 1401 West Commercial Avenue Lebanon MO 65536, or download it from the City of Lebanon webpage at www.lebanonmo.org.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The City of Lebanon hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award."

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2018 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening, and the bidder must be registered as a plan holder with the City.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified or cashier's check or a bid bond, 5% of the project estimate shall be submitted with each proposal.

The City of Lebanon reserves the right to reject any or all bids.

The DBE Goal for this project is 4%, no trainees.

No 2nd tier subcontracting will be allowed on this project.
