(Prevailing Local Time) on the 20<sup>th</sup> day of December, 2018, and then opened and read at 9:30AM in the chambers of the County Commission. The envelopes containing the bids must be sealed. addressed to the Franklin County Purchasing Department and designated "Bid for Construction of the Shawnee Ford Road Bridge, Bro-036(31)".

## The proposed work includes:

All work and materials including placing fill, grading, demolition of the existing structure, construction a new three span (90'-120'-90') Prestressed Concrete Nu-Girder Bridge, reinforced concrete box culvert extension and associated roadway work together with any incidental work on the above project. The project is located on Shawnee Ford Road approximately 11.7 miles northwest of Sullivan, MO in southwestwern Franklin County, MO.

Other bridge alternatives will NOT be considered by the County and should NOT be assumed by the bidder in preparing the base bid.

## A mandatory Pre-Bid Meeting will be held December 13, 2018; 9:00AM at 400 East Locust Street, Room 207; Union, MO. All prospective bidders will be required to attend this meeting. If not in attendance, your bid will be considered non-responsive and rejected.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

Franklin County hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award."

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and

Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

Franklin County reserves the right to reject any or all bids.

The DBE Goal for this project is 9%.

No 2<sup>nd</sup> tier subcontracting will be allowed on this project.
