

**PUBLIC WORKS PROJECT
NOTICE TO CONTRACTORS**

Sealed bids for **TRAFFIC MANAGEMENT ENHANCEMENTS LAMBERT INTERNATIONAL BOULEVARD, FEDERAL PROJECT NO. CMAQ-9901(644), ST. LOUIS, MISSOURI** will be received at St. Louis City Hall, **1200 Market, Room 208** until **1:45 p.m.** on the **29TH Day of JANUARY, 2019** and at that time will be publicly opened and read.

Proposals must be made on blank forms to be furnished by the President of the Board of Public Service and must be submitted to Room 208, City Hall.

PROPOSED WORK: The proposed work, hereinafter called the work: The work consists of making additions to the Airport's traffic monitoring system which includes the installation of Pan, Tilt, Zoom (PTZ) and Fixed Cameras, their operational support equipment and utility support connections. The work includes the expansion of the Airport's fiber optic cable systems as needed to support the camera data flow to selected data storage hub locations and the data transmission to the Real Time Information Systems center at St. Louis Lambert International Airport. The construction of camera data storage hubs with servers, switches, equipment racks and electrical power. The work consists of obtaining equipment licenses and making software purchases with licenses. The work includes coordinating camera installations with current Airport personnel, fiber splicing, fabrication of electronic equipment cabinets, testing fiber runs, etc. in preparation for the camera installations and then testing the camera operations once installed. The result is a system to take traffic counts, assess traffic flow and adjust the traffic signal timing to mitigated traffic congestion and reduce vehicular emissions at the Airport.

The work also includes concrete pavement and median removal and the installation of longer left turn lanes composed of concrete pavement and curb, and associated site management.

Purchased sets become the property of the prospective bidder and **no refunds** will be made.

There will be a Pre-bid meeting on Thursday, **January 10, 2019, at 1:00 PM** at 11495 Navaid Rd., Bridgeton, MO 63044, on the Fourth Floor in the Ozark Conference Room (Rm AO-4066).

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rates), or State Wage Rates, whichever is higher.

The Board of Public Service hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for and award.

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2018 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

The Board of Public Service reserves the right to reject any or all bids.

The DBE Goal for this project is **14%**.

No 2nd tier subcontracting will be allowed on this project.
