- H. REVISIONS TO BIDDER'S RIGHT OF ENTRY
 - Modify Bidder's Right of Entry, by replacing the first sentence of Section 1 with the following sentence: "For the period not to extend beyond January 29, 2019 JCMO hereby permits Bidder to enter upon JCMO property ("Property") on a tract of right of way of the Rock Island Line located at Mile Post 285.4 to 278.5 as further defined in documentation provided to Bidder, in Kansas City, Raytown, and Lee's Summit, Jackson County, Missouri, as may be necessary in connection with preparing a bid for shared use path construction, and for no other purpose.
- I. ACCESS POINTS Right-of-Way access points are included in this addendum.
- J. RESPONSES TO SUBMITTED QUESTIONS AND UPDATES:
 - a. Do the piles need to be galvanized? No, however, the exposed portion of the pile of the soldier pile walls shall be prepared and painted per the Contract Documents.
 - b. Can the MSE retaining walls be a pure gravity design without strapping? The Owner will accept, and encourages the use of gravity walls over walls with strapping, as long as the gravity wall design meets the desired design parameters listed in the plans.
 - c. Do the pedestrian bridges require shop drawings? Yes, there are design calculations and shop drawings required for the pedestrian bridges. Contractor and supplier must review the Plans and Specifications for further information.
 - d. Picnic tables and bicycle racks were deleted from the contract.
 - e. Additional temporary traffic control sign assemblies were added for anticipated needs.
 - f. Additional limestone slabs were added for improved access control.
- K. REVISIONS TO JOB SPECIAL PROVISIONS
 - 1. Amend Technical Specification TS-3, Section Q, by inserting the following:
 - a. Payment will be made per the requirements of this Section, and Section R. These items are not lump sum.
