2. NOTICE TO BIDDERS

3. REVISIONS TO BIDDING DOCUMENTS, CONTRACT DOCUMENTS AND SPECIFICATIONS

- A. **Due to numerous items and questions on Addendum 3, BID OPENING IS MOVED TO FEBRUARY 5, 2019 AT 2:15 P.M.** Jackson County Public Works (JCPW) is changing the Bid Opening from January 29, 2019 to February 5, 2019 for the project, Rock Island Rail Corridor Shared Use Path-North Segment.
