Sealed bids will be received until **10:00 am (CDT), May 7, 2019**, and then publicly opened and read at **Clinton City Hall, 105 E. Ohio, Clinton, Missouri 64735** for furnishing all labor, materials and equipment and performing all work necessary to rehabilitate Runway 4-22 at the Clinton Regional Airport. Rehabilitation will include crack repair, slurry seal, and pavement markings. Sealed bids submitted prior to the bid opening should be sent to **Ms. Christy Maggi, City Administrator, City of Clinton, 105 E. Ohio, Clinton, Missouri 64735**.

Addendums to the bid package will be issued through the online Plan Holders List; therefore, all prime bidders shall be responsible for downloading the bid documents from the online plan room in order to be included in the Plan Holders List. Prime bidders should be registered on the Plan Holders List in order to submit a bid on the project.

A prebid conference for this project will be held at **10:00 am (CDT), April 23, 2019, Clinton Regional Airport**.

**Contract Time.** The owner has established a contract performance time of **59** calendar days from the date of the Notice-to-Proceed. All project work shall be substantially completed within the stated timeframe. This project is subject to liquidated damages as prescribed in the project manual.

**Bid Security.** Each proposal must be accompanied by a bid guaranty in the amount of five (5) percent of the total amount of the bid. The bid guaranty may be by certified check or bid bond made payable to the **City of Clinton, Missouri**.

**Bonding Requirements.** The successful bidder will be required to furnish separate performance and payment bonds each in an amount equal to 100% of the contract price at the time of contract execution.

**Award of Contract.** Bids may be held by the **City of Clinton, Missouri** for a period not to exceed **Ninety (90)** days from the date of the bid opening for the purpose of evaluating bids prior to award of contract.

Award of contract will be based on the lowest aggregate sum proposal submitted from those bidders that are confirmed as being responsive and responsible. The right is reserved, as the **City of Clinton, Missouri** may require, to reject any bid and also the right to reject all bids.

Award of contract is contingent upon the owner receiving State-funding assistance under the State Aviation Trust Fund.

**State Wage Requirements.** The contractor will be required to comply with the wage and labor requirements and pay minimum wages in accordance with the schedule of wage rates established by the Missouri Division of Labor Standards included in the Supplementary Provisions.

**Additional Provisions.** Modification to the project documents may only be made by written addendum by the Owner or Owner's authorized Representative.

The proposal must be made on the forms provided within the bound project manual. Bidders must supply all required information prior to the time of bid opening.
