The Applicant shall carry commercial general liability insurance and commercial automobile liability insurance from a company authorized to issue insurance in Missouri, and to name the Commission, and MoDOT and its employees, as additional named insured in amounts sufficient to cover the sovereign immunity limits for Missouri public entities as calculated by the Missouri Department of Insurance, Financial Institutions and Professional Registration, and published annually in the Missouri Register pursuant to Section 537.610 R.S.Mo. Applicant shall inspect the property before vegetation control and evaluate all potential risks, both seen and unseen. Applicant waives all rights to claims against the Commission, and MoDOT, its officers, employees, agents and assigns; or any person, firm or corporation in privity with Commission and MoDOT arising due to injuries resulting from the actions of applicant, its agents, officers, employees, or assigns under the permit. Applicant also acknowledges that in the event a highway improvement project occurs during the period of this permit, it must receive prior approval from the contractor to continue utilizing the permit during the period of construction.
