INVITATION FOR BIDS

Sealed bids for the City of Union, Missouri (hereinafter "Owner") N. Christina Avenue Bridge Replacement, STP-6200(610) and Memorial Parkway Bridge Replacement, STP-6200(612) (hereinafter "Project") will be received by Union City Hall, 500 East Locust Street, Union, Missouri 63084, until 2:00 p.m. local time, on Tuesday, May 21, 2019, at which time the bids will be publicly opened and read aloud.

Scope of Work as follows:

<u>N. Christina Avenue Bridge.</u> Includes complete removal and replacement of the bridge on N. Christina Avenue over Flat Creek in the City of Union, Missouri. The project includes construction of the bridge, a 30' concrete slab span on concrete wall abutments. The project also includes construction of the approach roadway embankments and pavements, sidewalks, pavement striping, traffic control and other incidental items and work described in the Project Manual, or reasonably inferable therefrom.

<u>Memorial Parkway Bridge.</u> Includes the removal of the existing bridge over Flat Creek on Memorial Drive, construction of a new bridge, sidewalks, approach slabs, curb and gutter, asphalt pavement, pavement striping, guard rail, traffic control and other incidental items and work described in the Project Manual, or reasonably inferable therefrom.

The City of Union anticipates issuing notice to proceed in the Summer of 2019.

This will be a required combination bid and the two projects will be awarded to the low bidder of the combined projects under one contract.

Bid packages in the form of pdf electronic files on a CD or printed copies are available and may be obtained from the St. Louis office of Cochran located at 737 Rudder Road, Fenton, MO 63026 between the hours of 7:30 a.m. and 4:00 p.m., Monday through Friday, upon payment of a non-refundable fee of **\$30** for the CD format or **\$150/set** for a printed copy. Cash is acceptable, or make checks payable to Cochran (no credit cards can be accepted). When picking up or receiving a bid package, you will be required to provide: a contact name and phone number, a complete company address and an e-mail address for receiving official bidding communications and addenda. Project and bidding questions shall be conducted <u>exclusively</u> via e-mail. No written questions after this date or any verbal questions will be recognized.

A bid security in the amount of five percent (5%) of the bid amount must accompany each bid, in accordance with the Instructions to Bidders.

For a contractor to be awarded this project the contractor must have a fully responsive contractor questionnaire on file with the Missouri Highway and Transportation Commission at least 7 days prior to the bid opening date. All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the current Missouri Standard Specifications for Highway Construction. No Second Tier Subcontracting will be allowed.

The wage rates applicable to this project have been predetermined as required by law and are set forth in this specification. When Federal wage rates are applicable and included, this contract is subject to the "Work Hours Act of 1962", (P.L. 87-581: 76 Stat. 357) and implementing regulations. When state and federal wage rates are both required the higher of the two for each job classification shall be used.

Effective January 1, 2009 and pursuant to RSMo 285.530 (1), No business entity or employer shall knowingly employ, hire for employment, or continue to employ an unauthorized alien to perform work within the state of Missouri. The successful bidder must submit a sworn affidavit and documentation affirming the business entity's enrollment and participation in the federal work authorization program and that all of its employees working for the contracted services are not illegal immigrants.

Upon signing the contract, the successful contractor and any subcontractor performing the work shall provide a tenhour Occupational Safety and Health Administration (OSHA) construction safety program for their on-site employees within sixty (60) days of beginning work on the construction project.
