

The Missouri Department of Transportation is proposing to amend the state's five-year Statewide Transportation Improvement Program (STIP).

A 7-day public comment period regarding the urgent administrative amendment begins April 19, 2019 and ends April 26, 2019. The proposed April administrative amendment is attached below. The Missouri Highways and Transportation Commission approved the current Statewide Transportation Improvement Program in July 2018. Amendments occur due to unforeseen circumstances, changing conditions, or new opportunities that require a more rapid response than can be provided by an annual update.
