Sidewalk Project in Monroe City, Missouri

Notice to Contractors

Sealed bids for Monroe City Main Street Accessibility Improvements – Phase 1; TAP-9900 (389), will be received at: City Hall of Monroe City, 109 Second St., Monroe City, MO 63456, until 3:00 o'clock P.M. (Prevailing Local Time) on the 23 day of May, and at that time will be publicly opened and read. All bids shall be submitted in the form of a sealed envelope addressed to Monroe City, 109 Second Street, Monroe City, MO 63456. Provide the project name, vendor name, vendor address, county, route, and federal project number on the outside of the envelope.

The proposed work includes: The project involves removal and replacement of indicated sections of existing sidewalk to meet current ADA requirements along both sides of South Main Street between the Lawn/Mill Street intersection to the south side of the railroad crossing north of the Summer Street intersection. Project also includes side street/driveway removal and replacement, storm sewer construction, and utility adjustments.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The [City of Monroe City](#) hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.”

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

The project will be awarded to the lowest, responsive, responsible bidder. The [City of Monroe City](#) reserves the right to reject any or all bids.

The DBE Goal for this project is 4.0.

No 2nd tier subcontracting will be allowed on this project.
