Sealed bids for the construction of the **Berry Road Street Improvements** will be received by the City Clerk of Bonne Terre at the City Hall, 118 North Allen Street, Bonee Terre, MO 63628 until **2:00 PM on Friday, May 17, 2019** and at that time will be publicly opened and read aloud. A mandatory pre-bid meeting will be held at the City of Bonne Terre City Hall on **Wednesday, May 8, 2019 at 10:00 AM.**

The project includes: The expansion and 2" overlay of a section of Berry Road from Route 49 to approximately 400 feet north. The project also includes approximately 358 linear feet of curb and gutter, a new storm inlet, HDPE pipe, a concrete flume, striping and all other work necessary to make the project complete and useable.

Missouri law, 292.675 RSMO, requires the awarded contractor and its subcontractor(s) to provide a ten-hour occupational safety and health administration (OSHA) construction safety program (or a similar program approved by the Missouri department of labor and industrial relations as a qualified substitute) for their on-site employees (laborers, workmen, drivers, equipment operators, and craftsmen) who have not previously completed such a program and are directly engaged in actual construction of the improvement (or working at a nearby or adjacent facility used for construction of the improvement). The awarded contractor and its subcontractor(s) shall require all such employees to complete this ten-hour program, pursuant to 292.675 RSMO, unless they hold documentation on their prior completion of said program. Penalties for non-compliance include contractor forfeiture to the City of BONNE TERRE, Missouri in the amount of \$2,500.00, plus \$100 per contractor and subcontractor employee for each calendar day such employee is employed beyond the elapsed time period for required program completion under 292.675 RSMO.

The BIDDER shall comply with the Disadvantaged Business Enterprise (DBE) Contract Provisions. The goal for the **Berry Street Storm Improvements** is **0.00 %**.

The City of Bonne Terre, MO hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

If a contract award is made, it will be made to the lowest, responsive, responsible bidder. This is a prevailing wage project. State and Federal wage rates will be used for this project, the higher of the two for each job classification should be used.

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.
