

## ADVERTISEMENT FOR BID

Notice is hereby given that the City of Sunset Hills will receive sealed proposals at City Hall, 3939 S. Lindbergh, Sunset Hills, Missouri until 10:00 a.m. local time, on Wednesday, June 26, 2019, at which time all bids for the Lindbergh Boulevard Pedestrian Improvements – Phase 1 will be publicly opened and read.

The proposed project is located on Lindbergh Boulevard from Eddie & Park Road / West Watson Road to Rott Road / East Watson Road in Sunset Hills, Missouri. The work on this project consists of earthwork and grading, aggregate base, sidewalk and curb ramps, driveway pavement, pedestrian traffic signal heads, sodding and all other incidental and collateral work necessary to complete the work

The bid proposal shall be made on the forms provided and delivered in a sealed envelope clearly marked **Lindbergh Boulevard Pedestrian Improvements – Phase 1** to the City of Sunset Hills on or before the time specified above. No facsimiles will be accepted. The proposal shall be accompanied by a bid bond, certified check or cashier's check of a bank or trust company for an amount not less than five (5%) percent of the bid amount. The amount of the check shall be forfeited to the City if the bidder neglects or refuses to enter into a contract or to furnish bond after their proposal has been accepted.

The City reserves the right to reject any and all bids, offers, or proposals submitted, or to advertise for new bids with the MoDOT's concurrence. The City reserves the right to defer the acceptance of any proposal and the execution of a contract for a period not exceeding sixty (60) days after the date of opening of the bids. The successful bidder to whom the contract has been awarded shall sign the contract and performance bond and other required certificates in triplicate and return the signed documents within seven (7) days after the date of their receipt. The project will be awarded to the lowest, responsive, responsible bidder

The City of Sunset Hills hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

The DBE Goal for this project is **16%**.
