ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of Carroll County Bridge No. 40700011 on County Road 230 (near Bosworth, MO) will be received by the Carroll County Commission, at the office of the Carroll County Clerk, until 11:00 a.m. local time on July 26, 2019, at which time the Bids received will be publicly opened and read. The Project consists of removal of existing truss bridge with concrete foundations, construction of new concrete foundation on driven piles, supply and erect a 182' long modern pre-engineered steel truss with concrete deck, concrete barrier rail, and chain link fence. Furnish and install traffic control, roadway guard rail, rock blanket, aggregate surface, and related roadway and bridge items.

Bids will be received for a single prime Contract. Bids shall be on unit price basis, with additive alternate bid items as indicated in the Bid Form.

The Issuing Office for the Bidding Documents is: Howe Company, LLC, 804 E. Patton St, Macon, MO 63552. Prospective Bidders may examine the Bidding Documents at the Issuing Office on Mondays through Thursdays between the hours of 8:00 a.m. and 4:00 p.m., and may obtain copies of the Bidding Documents from the Issuing Office as described below.

Upon request and receipt of the document fee indicated above plus a non-refundable shipping charge, the Issuing Office will transmit the Bidding Documents via delivery service. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder's date of receipt of the Bidding Documents.
