This Addendum is herewith made a part of the Contract Documents of the above issued project and is issued to amend and supplement the May 12 2019 dated bid documents as follows:

SPECIFICATION REVISIONS/CLARIFICATIONS

Entire Document, Multiple Locations

Revise: In Bid Document, replace all references to 270 calendar days with 335 consecutive calendar days.

Entire Document, Multiple Locations

Revise: In Bid Document, replace all references to 22 foot wide runway broom to a runway broom of 16 foot minimum width.

Entire Document, Multiple Locations

Delete: The quantity of training hours identified for each piece of equipment performed by a qualified manufacturer's representative.

Add the following statement regarding the quantity of training provided by a manufacturer's qualified representative for awarded equipment: "At least 16 hours of training shall be provided by a manufacturer's qualified representative for the purpose of training airport personnel regarding the operation and maintenance of the awarded equipment. The date of training shall be scheduled in advance with the airport."

Section: Instruction to Bidders

Add new paragraph to page 8: **"Basis of Award**

1. A contract will be awarded to the lowest responsible bid determined by the Total Base Bid as identified on the Proposal Form.

2. The Owner will not consider alternate bid items in determining the low bid. The Owner may accept alternate(s) bid items after a successful low bidder has been determined."

3. A contract will be awarded to the lowest bidder who has responded to all conditions as set forth in this Information to Bidders and has submitted a complete and correct Proposal Form(s) including a completed Buy American Certification, pages 64 – 66 of the Proposal Form. Award of a contract is contingent upon the City receiving a federal grant from the FAA to fund the equipment.

Section: Technical Specification, Multi-Task Carrier Vehicle, First paragraph, 1st sentence, Page 37

Delete: Reference to Hands Free Hitch.

Section: Technical Specification, Technical Specification Overview, last (10th) paragraph, Page 38

Delete: Last Sentence.

Add to paragraph: "A qualified operator must be present to properly unload the equipment."

Section: Technical Specification, Multi-Task Carrier Vehicle, Transfer Case, Page 39 Revise: Reference to multispeed design. Add: "The transfer case assembly may be single or multispeed design."

Section: Technical Specification, Multi-Task Carrier Vehicle, Page 40 Delete: References to Reverse Slope Windshield.

Section: Technical Specification, Multi-Task Carrier Vehicle, Page 40 Revise: References to 24 volt dual battery system to "A 12 or 24 volt multiple battery system. Add: "Battery mounting hardware shall be constructed from non-corrosive material. Batteries shall be securely mounted and adequately protected against physical injury, water, chemicals and exhaust heat."

Section: Technical Specification, Multi-Task Carrier Vehicle, Page 41 Delete: References to Automatic Hitch and locking devices activated through the use of existing vehicle power.

Modify: The final lock on of the various attachments to the multi-tasking carrier vehicle can be manually accomplished.

<u>Section: Technical Specification, Multi-Task Carrier Vehicle, Page 41</u> Revise References to cold weather ether start system to the following: "The MTE must be equipped with a cold weather ether start system or a heated intake grid heater start system."

Section: Technical Specification, Front Mounted 22 foot Wide Runway Broom, Page 48 Revise: References to 22 wide foot rotary broom to a runway rotary broom of 16 foot minimum width.

Section: Technical Specification, Front Mounted 22 foot Wide Runway Broom, Auxiliary Equipment, Optional brush wafers and cassettes, Page 48 Delete: "Optional brush wafers and cassettes" line item. Add: "The bristle configuration for the runway broom may be wafer or cassette style."

Section: Technical Specification, Multi-Task Carrier Vehicle, Page 48 Delete: References to "An Automatic Lubrication System for all Possible Points."

Section: Technical Specification, Front Mounted 18 foot Wide Snow Plow, Page 52 Add: "In addition to a uniform height plow. a flared end plow shall be added as a 3rd Alternate Bid item. The first two pages of the Proposal Form have been revised and attached to this Addendum Number 1."

Section: Technical Specification, Front Mounted 18 foot Wide Snow Plow, 2nd Sentence in first paragraph on Page 52

Rewrite: "The cutting edge must not ride in contact with the pavement but be elevated by a small distance above it by means of shoes or caster wheels."

Section: Technical Specification, Front Mounted 18 foot Wide Snow Plow, Operational, Page 52

Rewrite to read: "The snow plow moldboard assembly shall be made of polyethylene material conforming to the material requirements presented in the SAE ARP 5943 specification".
