The charge for Plans and Specifications shall be <u>One Hundred-Fifty and 00/100 Dollars (\$150.00)</u>. No refunds will be made for plans and specifications used during or referred to during the bidding process.

The Proposal shall be accompanied by a certified or cashier's check drawn on a solvent Missouri bank or trust company made payable to the <u>City of Bowling Green</u>, <u>Missouri</u>, or a Bid Bond issued by a surety licensed to conduct business in the state of Missouri and appearing on the U.S. Treasury Department's most current list (Circular 570, as amended), in the amount of not less than five percent (5%) of the total bid. The Bid Bond may be retained by the <u>City of Bowling Green</u>, <u>Missouri</u>, as a guaranty that if the Proposal is accepted, the bidder will execute the Contract and file an acceptable Performance Bond and Payment Bond within <u>fifteen (15) days</u> after the award of the Contract.

This project will be advertised at least twenty one (21) calendar days before the receipt of bids.

Bidders on this Work will be required to comply with the Copeland (Anti-Kickback) Act, and the Contract Work Hours and Safety Standards Act, as indicated in the Contract Documents.

Any Contract or Contracts awarded under this Advertisement to Bid are expected to be financed through the Federal Highway Administration (FHWA) and the Missouri Department of Transportation (MoDOT) TAP Enhancement Fund Program. Neither the FHWA, nor MoDOT or the United States or any of its departments, agencies, or employees is or will be a party to this Advertisement to Bid or any resulting Contract. Procurement will be subject to regulations contained in 40 CFR, Part 33 and Part 31.36(e). These regulations are contained in the Contract Documents.

The Contractor doing the work must pay labor at rates not less than those certified pursuant to Section 290.210-.340, RSMo. (1986) by the Missouri Department of Labor and Industrial Relations as indicated by the schedule included in the Contract Documents. The Contractor shall forfeit as a penalty to the City, Ten and 00/100 Dollars (\$10.00) for each workman employed, for each calendar day, or portion thereof, such workman is paid less than the said stipulated rates for any work under said Contract by him or by any subcontractor under him. Section 290.250.

The Contractor shall also comply with the document entitled Labor Standards Provision for Federal and Federally Assisted Contracts, U.S. Environmental Protection Agency Form 5720-4 (Rev. 5-87), which is included as part of the Contract Documents.

Buy America Requirement. Contractor is required to follow MoDOT specification 106.9 which directs Contractor's attention to Title 23, CFR, titled Buy America Requirements. Iron and Steel material shall be manufactured in the USA and furthermore any coating process of the steel or iron shall be performed in the USA.

Each bidder must fully comply with the requirements, terms and conditions of the EPA Region VII, Disadvantaged Business Enterprise (DBE), Minority Business Enterprise (MBE), and Women's Business Enterprise (WBE) requirements. The Bidder commits itself to the affirmative steps for DBE/MBE/WBE participation contained within the Specifications and all other requirements, terms and conditions of the DBE/MBE/WBE participation conditions when submitting a properly signed bid. <u>The DBE project goal is</u> <u>0% percent.</u>

The <u>City of Bowling Green, Missouri</u> may reserve the right to reject all bids. Unless all bids are rejected for good cause, award of the contract shall be made to the low, responsive, responsible bidder. No bids may be withdrawn for a period of sixty (60) days subsequent to the specified time for receipt of bids.

Existing plan holders will receive a Re-Bid Proposal packet and will be required to submit a copy of E-Verify with their respective bid package. All new plan holders will use the documents provided in the specifications. Make sure you submit a Bid Proposal, Bid Bond, Anti-Collusion Statement, and E-Verify in your Bid Proposal package or your bids will be considered non-responsive and will not be read.

The Notice to Proceed date will be July 24, 2019. The Contractor may begin construction after the Preconstruction Conference, in advance of the Notice to Proceed date, weather permitting.
