

INVITATION TO BID

MILLER ROAD IMPROVEMENTS

Sealed bids for the Miller Road Improvements STBG-5944(803) will be received at: City of Willard, Willard City Hall, P.O. Box 187, WILLARD, MISSOURI 65781, until 10:00 o'clock A.M. (Prevailing Local Time) on the 29 day of August 2019, at the office of the Willard City Hall, and at that time will be publicly opened and read. All bids shall be submitted as a Hard Copy.

The proposed work includes:

Construction of Roadway Improvements to Miller Road between Jackson Street and New Melville / Farm Road 84, storm water improvements between Mill Street and Beam Street, and the installation of new waterline between Jackson Street and New Melville. Improvements include roadway widening, curb and gutter, sidewalk, stormwater improvements, new waterline installation, grading, restoration, and any incidental work in accordance with the plans and specifications.

A digital copy of the plans and specifications may be purchased through the office of Great River Engineering (GRE), at 2826 S. Ingram Mill, Springfield, MO 65804 (417-886-7171) upon payment of \$75.00, which is not refundable. All bidders must purchase plans through Great River Engineering, Inc. and be on the planholder list in order to bid the project.

A pre-bid conference will be held at 2:00 P.M. on the 20th of August at Great River Engineering, 2826 South Ingram Mill, Springfield, MO 65804. All bidders are encouraged to attend the pre-bid meeting.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the United States Department of Labor (Federal Wage Rate), or by the Missouri Department of Labor and Industrial Relations (State Wage Rate), whichever is higher.

The City of Willard hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2019 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works projects shall provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

The City of Willard reserves the right to reject any or all bids.

The project will be awarded to the lowest, responsive, responsible bidder.

The DBE Goal for this project is 7%.

No 2nd tier subcontracting will be allowed on this project.
