The proposed work includes: Construction of an at-grade reinforced concrete pad (approximately 160 feet by 116 feet), sidewalk (approximately 110 feet in length), and two (2) deadman structures on the shoreline of the Mississippi River, as well as a potable water line, in Kimmswick, Missouri. The site is approximately located at Mississippi River Mile 158.8, Right Descending Bank (RDB), just north of Rock Creek. All bidders are encouraged to attend the prebid meeting. Attendance is not required. All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher. The Jefferson County Port Authority hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award. All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2018 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening. Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project. A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal. The Jefferson County Port Authority reserves the right to reject any or all bids.
