<u>Bid Conditions.</u> The bidder is required to provide all information as required within the Contract Documents. The bidder is required to bid on all items of every schedule or as otherwise detailed in the Instructions to Bidders.

Each proposal must be accompanied by a bid guaranty in the amount of five (5) percent of the total amount of the bid. The bid guaranty may be by certified check or bid bond made payable to City of Kennett.

Bids may be held by City of Kennett for a period not to exceed 90 calendar days from the date of the bid opening for the purpose of evaluating bids prior to award of contract.

The right is reserved, as City of Kennett may require, to reject any and all bids and to waive any informality in the bids received.

Construction for this project is expected to take 25 Calendar Day(s) for Schedules I and II, with an additional 30 Calendar Days granted for Schedule III.
