Bidders on the Belton I-49 Outer Road Project are hereby notified that the following addenda are made to the Project Contract Documents. In response to a question posed at the pre-bid meeting, approved equals are allowed per Section 6.04 in the General Conditions and the Supplementary Conditions. Approved equals for Lime Treated Subgrade have been listed with Line Item 17 on the updated Bid Form and Unit Prices sheet.

### **Item 8: Bid Items**

- The quantity for Bid Item 8. Coldmilling Bituminous Pavement for Removal of Surfacing (3 in. thick or less) has changed from 8,467 square yards to 4,302 square yards.
- Bid Item 9. MoDOT Type 5 Aggregate for Base (4") has been removed from the bid item list.
- The quantity for Bid Item 11. APWA Asphalt Surface, Type 3-01 has changed from 1,689 tons to 1,249 tons.
- The quantity for Bid Item 12. APWA Asphalt Base, Type 1-01 has changed from 4,941 tons to 5,040 tons.
- Bid Item 14. Concrete Pavement (8 in. Non-Reinf) (160<sup>th</sup> St) has been removed from the bid item list.
- The quantity for Bid Item 17. Lime Treated Subgrade has changed from 10,066 square yards to 10,341 square yards.
- The quantity for Bid Item 18. Tack Coat has changed from 847 gallons to 431 gallons.
- An additional Bid Item (A1) shall be added for Full Depth Street Patch with a quantity of 4,165 tons.
