**Moberly, MO – Sidewalk Improvements Project**  
**Federal Aid Project No. TAP-4500(209)**

Located along Route M from Chrisman Lane to Cedar Ridge Lane in the city of Moberly, Missouri.

Bids will be received and opened publicly at the office of the Moberly City Hall, 101 W Reed St, Moberly, MO 65270 at, **2:00 P.M. on 8<sup>th</sup> of August, 2018.**

Any and all bids received after the time specified above will be returned unopened.

The project includes the construction of sidewalk along the south side of Route M from Chrisman Lane on the west, to Cedar Ridge Lane on the east. There will also be a pedestrian crossing of Route M just west of the intersection with Gratz-Brown Street. The sidewalk will then continue north to connect with an existing city trail system. The sidewalk will utilize MoDOT or City Right-of-Way for the western portion of the sidewalk, as well as the spur north. The eastern portion of the sidewalk will utilize some public Right-of-Way as well as permanent easement. The sidewalk will require one crossing of a drainage ditch utilizing a culvert, and one crossing utilizing a wooden pedestrian bridge. No structures will be impacted as part of this project.

The wage rates applicable to this project have been predetermined as required by law. When Federal wage rates are applicable and included, this contract is subject to the "Work Hours Act of 1962", (P.L. 87-581: 76 Stat. 357) and implementing regulations.

The City of Moberly hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2017 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works projects must provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.
