Sealed bids for the Summit Road CRS Overlay project will be received at the **Office of the Director of Procurement for the County of St. Louis, County Government Center Administration Building, 41 South Central Avenue, 8<sup>th</sup> Floor, Clayton, Missouri 63105**, until 2:00 p.m. on **July 25, 2018**, and at that time will be publicly opened and read.

St. Louis County Project No. CR-1575, Federal Project No. STP-5419(608) consists of removal and replacement of deteriorated and/or damaged pavement, curbs and sidewalks; Superpave asphaltic concrete overlay, removal and replacement of sidewalk curb ramps, sodding, and other incidental items on Summit Road from the end of maintenance on the west side of Gravois Road (Mo. Route 30) to Bowles Avenue within St. Louis County.

The successful Bidder or Bidders shall be required to comply with the most current applicable Federal (Davis-Bacon Act) and State statutory provisions concerning the payment of prevailing wages on public works, Section 290.210 through 290.340 R.S. Mo. 1959, as amended. All contractors must be on the Missouri Department of Transportation's approved contractor listing, seven (7) days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on a public works project shall provide a ten (10) hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.
