- CHANGE Section 2.3.A. Crossties New AREMA IG crossties 7"x 9"x 8'-6" for use in track construction, DELETE "and new AREMA grade 7"x 9"x 10'- 0"for use in the two crossings," oak and acceptable hardwoods. 100% anti-splitting devices and incised. Pressure treated pursuant to AREMA Chapter 30 with a net creosote retention of seven (7) pounds per cubic foot for oak and eight and one-half (8-1/2) pounds per cubic foot for mixed hardwoods. Ties shall not be pre-bored.
- CHANGE Section 2.5.C. Tie plates, new or good quality relay, double shoulder tie plates that match the rail base for 115# rail and heavier. Tie plates shall be minimum 1.5 times the base of rail and at rail joints must be able to be spiked on both sides along the base of rail and have 8 holes. Provide tie plates at a quantity of two (2) per crosstie having a total tie plates provided of 2,400 each.
