Bids will be opened after that time at the same location.

This project is funded in part with funds offered by the Missouri Department of Transportation (MoDOT). The City of Kansas City, Missouri, hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

Prior to Bidding, Prime Contractors must have a fully responsive contractor questionnaire on file with the Missouri Highways and Transportation Commission (MHTC) at least seven (7) days prior to the bid opening date. Subcontractors utilized for DBE Goals must appear on the MoDOT/Kansas City Approved DBE List and on the MoDOT DBE Directory located at http://www.modot.mo.gov/business/contractor_resources/bid opening info/bidGenInfo.shtml.

Each bidder must certify that it is not presently debarred, suspended, proposed for debarment, declared ineligible or voluntarily excluded from covered transactions by any federal agency and they have not been convicted or had civil judgment rendered within the past 3 years.

The contract will be awarded to the lowest, responsive, responsible bidder.
