The project shall consist of:

Replace an aging and inadequate bridge with a new single span pre-engineered concrete bridge.

The DBE (Disadvantaged Business Enterprise) contract goals for the amount of work to be awarded for the Ste. Genevieve County Jackson School Rd. Bridge over Goose Creek, is 4% the total project price. The bidder shall also complete the DBE Identification Submittal forms in accordance with the General Provisions. Missouri Law, 292.675 RSMO, requires any awarded contractor and its subcontractor(s) to provide a ten-hour Occupational Safety and Health Administration (OSHA) Construction Safety Program for their on-site employees.

The Owner must award the project to the lowest responsive, responsible bidder. All bidders are required to use the prequalification process outlined by MoDOT. See the Missouri Standard Specifications for Highway Construction, Section 102 for additional information. Each Bidder must deposit with his bid, security in the amount, form, and subject to the conditions provided in the Information for Bidders. No Bidder may withdraw his bid within <u>60</u> days after the actual date of the bid opening.
