The proposed work shall include removal and replacement of the Possum Hollow Bridge on Possum Hollow Road within Franklin County with a single span adjacent box beam bridge. The project is limited to approximately 700 feet of roadway widening from one lane to two across the new bridge. The new bridge will be constructed under staged construction and is anticipated to be a precast prestressed concrete adjacent deck beam bridge with concrete abutments founded on piles set in rock.

No 2nd tier subcontracting will be allowed on this project.
