The construction contract for this project has been revised as follows:

No. 1

Added Special Provision 400.30.4 FULL DEPTH ASPHALT BASE REPAIR as follows:

400.30.4 FULL DEPTH ASPHALT BASE REPAIR

Description

- A. This work shall consist of saw cutting, full depth asphalt pavement removal, subgrade preparation, and placement and compaction of full depth type 'X' asphalt base pavement in lifts in accordance with section 405.12.1 of the "Standard Specifications for Road and Bridge Construction Manual".
- B. Locations to be repaired shall be as indicated in the construction plan or as determined by the Engineer.
- C. Repair thickness shall match the existing pavement section. Approximate pavement thicknesses have been included in the construction plans.
- D. Where the existing subgrade has been determined by the engineer to be acceptable to use in place, the contractor shall level and prepare the subgrade material prior to placement of asphalt base material.
- E. Where the existing subgrade has been determined by the engineer to be unacceptable to use in place, the contractor shall remove the existing subgrade and place and compact 4" of type 5 aggregate base prior to placement of asphalt base material.

Method of Measurement

- A. Measurement shall be taken to the nearest (0.1) Ton for the item 405.30.30 TYPE "X" BITUMINOUS CONCRETE (BASE).
- B. Thickness will be measured to the nearest inch by the Engineer after preparation of the subgrade has been completed and accepted.

Basis of Payment

- A. Payment for saw cutting, pavement removal, preparation of subgrade to be used in place, type 'X' asphalt pavement, Tack Emulsified Asphalt(SS-1H), and disposal of materials, including any handwork necessary to complete the repair, will be made per ton of completed repair at the contract unit price for Item No. 405.30.30 TYPE "X" BITUMINOUS CONCRETE (BASE).
- B. Removal, replacement, and disposal of unacceptable subgrade material shall be paid for at the contract unit price for 304-05.04 "Type 5 Aggregate Base (4" Thick").
