PUSHBUTTON-INTEGRATED AUDIBLE PEDESTRIAN SYSTEM (APS) SHALL HAVE A SPEAKER AND A VIBRATING SURFACE WITH ARROW ON ALL PUSHBUTTONS. ALL CABLES, MOUNTING HARDWARE, AND MISCELLANEOUS EQUIPMENT NECESSARY FOR A COMPLETELY FUNCTIONAL APS WILL BE CONSIDERED INCIDENTAL. INSTALLATION AND PROGRAMMING OF THE APS EQUIPMENT SHALL COMPLY WITH SECTION 4E.09—4E.13 OF THE MUTCD, 2009 EDITION. SIGNAGE MUST CONTRIAN STREET NAMES IN BRAILLE. PRIOR TO PROCUREMENT OF ALL APS RELATED EQUIPMENT, THE CONTRACTOR SHALL CONFIRM VERBAL INFORMATION FOR STREET CROSSINGS WITH THE CITY OF WENTZVILLE AND MODOT.
- (4) ALL PEDESTRIAN HEADS SHALL HAVE A "COUNTDOWN" DISPLAY WITH "WALKING PERSON SYMBOL AND AN UPRAISED HAND SYMBOL".
