It is the intent of these documents and accompanying drawings to prescribe the color video recording of surface features located within the zone of influence of construction supported by simultaneous audio description of said features. Three (3) copies of pre-construction items and three (3) copies of post-construction items shall be submitted to the City.

Such coverage shall include, but not be limited to, all existing concrete channels, fences, visible utilities, the Lowry Residential building (Interior and Exterior), and the Hopson Lumber Commercial building located within such zones of influence. Of particular concern are any existing cracks, fractures, defects, or other deficiencies exhibited by the abovementioned surface features. For access to the Lowry Residence Interior, please call the Property Caretaker at 636.208.6608.

Houses, and buildings shall be identified visually by house or building number, when possible, in such a manner that the progress of the taping may be located by reference to the houses and buildings.

Audio-video taping shall occur after the proposed construction work has been staked and prior to any construction.

Audio-video taping shall occur again after construction and prior to the City signing off on the Project.

Detail Requirements.

- 1. Audio-video digital media shall be submitted on DVD.
 - a. All DVDs shall be properly identified by disc number, location, and project name in a manner acceptable to the City.
 - b. A record of the contents of each DVD shall be supplied on a run sheet identifying each area on the DVD by address location and time location. An example run sheet is included with this specification.
 - c. The Contractor will use the run sheet from the pre-construction audio-video recording as the basis for determining the order of footage for the post-construction audio-video recording.
 - d. A brief report and inventory of all DVDs completed, referenced by location and DVD number, shall be furnished to the City upon completion of the work and delivery of the DVDs.
- 2. The audio-video DVD shall have the potential to convey 1 video and 1 audio tracks. The video and one audio track (Audio Track 1) must be recorded simultaneously as original live recordings and shall not be copies of other audio or video recordings. These live recordings shall consist of a fixed elevation video record of the zone of influence of construction and the commentary of the electographer making that video record.
- 3. All video recordings must, by electronic means, display continuously and simultaneously generated transparent digital information to include the date and time of recording.

The date (month, day, and year – numerically) information must appear in a corner of the picture, similar to the following manner:

- 4. All recording shall be done during times of good visibility. No outside taping shall be done during periods of visible precipitation or when the ground area is covered with snow, leaves, or debris unless otherwise authorized by the City.
- 5. The average rate of speed in the general direction of travel of the conveyance used during taping shall not exceed 48 feet per minute. Panning rates and zoom-in/zoom-out rates shall be controlled sufficiently such that playback will produce adequate clarity of the objects being viewed.
- 6. When planning on entering private property, the Contractor shall notify the Owner of such property in advance of the planned entry to obtain his permission to do so. Should the Owner of the property refuse to give his permission for said entry, the Contractor shall immediately notify the Engineer, who will obtain the right to enter the property through the legal powers vested in the City as public entity.

The Contractor is advised that he shall not enter any private property before permission is granted to do so or the Engineer notifies the Contractor that he has gained the legal right to do so. The contractor shall be held liable for entry made other than as stated above.

7. All DVDs produced under this contract will become the permanent property of the City. The Contractor shall deliver all DVDs to the City within thirty (30) days after the completion of the work. Three (3) sets of all items are required.
