Sealed bids for the City of New Melle, Highway Z & D Sidewalk Improvements – STP 5414 (621) (hereinafter "Project") will be received by New Melle, City Hall, 145 Almeling Street, New Melle, MO 63365, until 2:00 p.m. local time, on <u>Wednesday August 16, 2017</u>, at which time the bids will be publicly opened and read aloud.

The Scope of Work includes approximately 3,654' of improvements including new 5' wide concrete sidewalks, concrete driveways and approaches, storm sewers, pavement striping, traffic control and other incidental items and work described in the Plans and Project Manual, or reasonably inferable therefrom. The City of New Melle anticipates issuing notice to proceed in September 2017. A non-mandatory prebid meeting will be held on Wednesday, August 9, 2017 at 2:00 p.m. in New Melle City Hall.

Bid packages will be available after <u>Thursday</u>, July 20, 2017 and may be obtained from the Wentzville office of Cochran located at 8 E. A bid security in the amount of five percent (5%) of the bid amount must accompany each bid, in accordance with the Instructions to Bidders.

For a contractor to be awarded this project the contractor must have a fully responsive contractor questionnaire on file with the Missouri Highway and Transportation Commission at least 7 days prior to the bid opening date.

The wage rates applicable to this project have been predetermined as required by law and are set forth in this specification. Federal wage rates are applicable and included, this contract is subject to the "Davis-Bacon Act of 1931 and is prescribed by 23 USC 113" and implementing regulations. When state and federal wage rates are both required the higher of the two for each job classification shall be used.

Effective January 1, 2009 and pursuant to RSMo 285.530 (1), No business entity or employer shall knowingly employ, hire for employment, or continue to employ an unauthorized alien to perform work within the state of Missouri. The successful bidder must submit a sworn affidavit and documentation affirming the business entity's enrollment and participation in the federal work authorization program and that all of its employees working for the contracted services are not illegal immigrants.

Upon signing the contract, the successful contractor and any subcontractor performing the work shall provide a ten-hour Occupational Safety and Health Administration (OSHA) construction safety program for their on-site employees.

The City of New Melle, Missouri hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

The DBE Contract Goal for this project is 13%, and DBE firms must be certified by MoDOT to attain credit towards this contract goal. The On the Job Trainee goal is 0 hours. No trainee hours will be required under this contract.
