

INVITATION FOR BIDS

July 26, 2017

Sealed bids for the construction of TAP-9900(751) Business 60 Sidewalk and Water Main Improvements will be received by City of Rogersville, MO, at the Rogersville City Hall, 211 E. Center Street, Rogersville, MO 65742, until 2:00 pm (daylight savings local time) on August 23, 2017, at which time the Bids received will be publicly opened and read.

The Base Bid scope of work: Includes approximately 1996 SY of 4" thick 5' wide concrete sidewalk, 260 SY of 6" thick concrete pavement and 838 SY of 8" thick concrete pavement; storm boxes, pipe and ditch drainage improvements; site excavation and grading, surface repair and restoration, plus all appurtenant work thereto as specified or indicated in the drawings.

Add Alternate One scope of work: Includes Class 200 PVC water line improvements consisting of approximately 150 linear feet of 8" and 1,235 linear feet of 10" service main installation with gate valves, boxes, fire hydrant assemblies, service meter reconnections, connection to existing water lines, site excavation and grading, surface repair and restoration, plus all appurtenant work thereto as specified or indicated in the drawings.

Add Alternate Two scope of work: Includes approximately 33 SY of 8" thick concrete pavement; Class 200 PVC water line improvements consisting of approximately 20 linear feet of 8" and 296 linear feet of 10" service main installation with gate valves, boxes and connections to existing water lines, temporary line and service connections, surface repair and restoration, plus all appurtenant work thereto as specified or indicated in the drawings.

Bids shall be on a Unit Price basis.

A pre-bid conference will not be held.

Bid security shall be furnished in accordance with the Instruction to Bidders. Each bidder shall file with his bid a cashier's check, certified check or a bidder's bond for 5 percent of the total amount of the bid made payable to the City of Rogersville, Missouri, hereinafter referred to as OWNER, as security that the bidder(s) to whom the award(s) are made will enter into contract to build the improvements bid upon and furnish the required bonds and insurance. The City of Rogersville reserves the right to accept any bid which it deems most advantageous to the City, and to reject any or all bids submitted and to hold as many bids as it desires for consideration for a period of sixty (60) days after the bids are open.
