Sealed Bids for the construction of the **SOUTH TIF- 30<sup>TH</sup> STREET EXTENSION** will be received, by **The City of Bethany, Missouri**, at the **City Hall, 206 N. 16<sup>th</sup> St. Bethany, MO 64424**, until **3:00 p.m.** local time on **August 3, 2017** at which time the Bids received will be **publicly** opened and read. The project consists of constructing sanitary sewer, grading, precast concrete storm water inlets and reinforced concrete pipes, corrugated metal pipe culverts, aggregate base, concrete or asphalt pavement, erosion control, maintenance of traffic, and incidentals.

Bids will be received for a single prime Lump Sum Contract. The project contains scope of work for a Base Bid and Additive Alternates. The contract will be a Lump Sum based on unit prices and plan quantities, with additive alternates as indicated in the Bid Form.
