An endorsed "Proposal" for construction or improving the following routes and projects in the City of Festus, will be received by the City until 2:00 o'clock P.M. (Prevailing Local Time) on the 31st day of July, 2017 at the City of Festus, Public Works Department, 950 N. 5th Street, Festus, MO 63028 and at that time will be publicly opened and read.

The proposed work includes: Grading, paving, drainage, traffic control and installation of a new traffic signal at the intersection of Missouri Route A and Pounds Road with interconnect to the adjacent signal at Route A and Collins Drive. The work shall be in accordance to these Specifications, Job Special Provisions, as well as the project plans. Where not specifically covered by the Specification or Job Special Provision, the Contractor shall adhere to the 2016 Edition of the "Missouri Standard Specifications for Highway Construction".

Special Needs: If you have special needs addressed by the Americans with Disabilities Act, please notify the City of Festus at 636-937-4694, c/o Greg Camp, or through Missouri Relay System, TDD 1-800-735-2966, at least five (5) working days prior to the bid opening.

The wage rates applicable to this project have been predetermined as required by law and are set forth in this appendices. When Federal wage rates are applicable and included, this contract is subject to the "Work Hours Act of 1962", (P.L. 87-581: 76 Stat. 357) and implementing regulations.

The City hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

The prime contractor must be on the MoDOT approved contractor listing and must have a Contractor Questionnaire and/or Contractor Prequalification Questionnaire with attachments on file with MoDOT not later than seven (7) days prior to the date and hour of the bid opening. See Secs 101-103 of the Standard Specifications, and Rule 7 CSR 10-15.900, "Prequalifications to Bid of Certain Contractors". Questionnaire and Contact information are provided on MoDOT's website. The prime contractor on a project must perform, with its own staff, contract work amounting to NOT less than 30% of the total original contract price.

Plans and specifications may be inspected or picked up the City of Festus, Public Works Department, 950 N. 5th Steet, Festus, MO 63028. Complete instructions to bidders and proposal blanks may also be obtained from the City of Festus, City Hall. Proposals must be on forms provided.

The DBE Contract Goal for this project is 12%, and DBE firms must be certified by MoDOT to attain credit towards this contract goal. Ther is no On the Job Trainee goal.
