INVITATION TO BID

Sealed bids for the Schoettler Road Bridge project 2013-PW-18, Federal Project BRM-5410(623) will be received at Chesterfield City Hall (690 Chesterfield Parkway West, Chesterfield, MO 63017) until 10:00 am (prevailing local time) on 6th day of July, 2017 and at that time will be publicly opened and read. All bids shall be submitted in paper form.

The proposed work includes the removal and replacement of the existing structure of the Schoettler Road bridge over Creve Coeur Creek with a 55 foot long single span prestressed girder superstructure on integral end bents, 815 feet of improvements to Schoettler Road, driveway improvements, sidewalk, and any incidental work on the above mentioned project. This project extends from Sycamore Manor Drive to Greenleaf Valley Drive. Staged construction will be required to maintain traffic along Schoettler Road during the construction of this project.

When downloading, you will be required to provide your name and company information on a bidder's list record and furnish an email address for receiving official bidding communications and addenda. No oral interpretation will be recognized.

A pre-bid conference will be held at 10:00 am on the 27th day of June, 2017 at Chesterfield City Hall. **All bidders are encouraged to attend the pre-bid meeting.**

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The City of Chesterfield hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, business owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against based on the grounds of race, color, religion, sex, age, ancestry, or national origin in consideration for an award.

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified or cashier's check of a bid bond in the amount of 5% shall be submitted with each proposal.

The City of Chesterfield reserves the right to reject any or all bids.

The DBE goal for this project is 12%.

No 2nd tier subcontracting will be allowed on this project.
