INVITATION TO BID

The City of Rolla hereby requests bids for the following project: Salem Avenue Improvements, Project 401, Federal Aid Project No. STP-5200 (917).

Bids will be accepted until 11:00 a.m., on Tuesday, May 9, 2017, in the office of the City Clerk, 3rd Floor, 901 North Elm Street, Rolla, Missouri, at which time they will be opened. Bids shall be submitted in a sealed envelope and clearly marked "Salem Avenue Improvements, Project 401". Project consists of overlay and curb ramp improvements on Salem Avenue in the City of Rolla.

The Contractor shall be responsible for compliance with Section 290.250 of the Revised Missouri Statutes pertaining to prevailing wages.

Bidders are informed that pursuant to Section 285.530, R.S.Mo, as a condition of the award of any contract in excess of five thousand dollars (\$5,000.00), the successful bidder shall, by sworn affidavit and provision of documentation, affirm its enrollment and participation in a federal work authorization program with respect to the employees working in connection to the contracted services. Successful bidders shall also sign an affidavit affirming that it does not knowingly employ any person who is an unauthorized alien in connection to the contracted services.

Bidders are informed that the project is subject to the requirements of Section 292.675, R.S.Mo, which requires all contractors or subcontractors doing work on the project to provide, and require its on-site employees to complete a ten (10) hour course in construction safety and health approved by the Occupation Safety and Health Administration ("OSHA"), or a similar program approved by the Missouri Department of Labor and Industrial Relations which is at least as stringent as an approved OSHA program. The training must be completed within sixty (60) days of the date work on the project commences. On-site employees found on the worksite without documentation of the required training shall have twenty (20) days to produce such documentation.

All bidding Contractors shall be expected to review the scope of the work with a representative of the City Public Works Department prior to bidding and attend the pre-bid conference, scheduled for Tuesday, May 2, 2017 at 11:00 a.m. in the Public Works Department-4th Floor.

All bids shall be on the proposal form provided and shall be accompanied by submittals and a bid bond issued by an acceptable surety company and payable to the order of the City of Rolla, for not less than five percent (5%) of the total amount of the bid.

The City of Rolla hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, Disadvantaged Business Enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, sex, or national origin in consideration for an award.

The successful Contractor shall be expected to proceed as expeditiously as possible upon receipt of the NOTICE TO PROCEED and complete the project by **August 11, 2017**. The successful contractor will be required to have a City of Rolla business license.

The Contractor shall perform with its own organization contract work amounting to not less than 30 percent of the total original contract price, excluding any specialty items designated by the State.

Payment shall be based on actual measured quantities.

The project will be awarded to the lowest, responsive, responsible bidder.

The City reserves the right to reject any and all bids. All work shall be done in adherence to the City of Rolla Standards and Specifications, and Missouri Standard Specifications for Highway Construction (2016). Where these are in conflict, the City of Rolla Standards and Specifications shall be followed on City right-of-way, MoDOT Specifications on MoDOT right-of-way.

The 2016 Missouri Standard Specifications for Highway Construction as well as updates to the specifications can be viewed at: http://www.modot.state.mo.us/business/standards and specs/highwayspecs.htm. The updates can be found in the supplemental Specifications and the General Provisions and Supplemental Specifications at the MoDOT site.

Section 109.14 of the Missouri Standard Specifications for Highway Construction, 2016 Edition will be excluded from the specifications for this project.

DBE for this project shall be zero (0%) percent.

There do not appear to be any utilities that need to be moved in relation to this project. It is the contractor's responsibility to verify the location of all existing utilities. Please refer to the index sheet of project plans for phone numbers associated with appropriate utility companies.

Specifications and plans will be available electronically or if hard copies are preferred, they may be purchased for \$50.00 from the Rolla Public Works Department, Rolla City Hall, 4th Floor, 901 North Elm Street, Rolla, Missouri 65401. Bid documents can be picked up Monday through Friday, 8:00 a.m. to 5:00 p.m.
